ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on November 28, 1973, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this 6th day of December, 1973, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new oil pool in McKinley County, New Mexico, for the production of oil from the Mesaverde formation, said pool to bear the designation of Blackeye-Mesaverde Oil Pool. Said Blackeye-Mesaverde Oil Pool was discovered by the K & W Oil Co. Jaco No. 55-Y located in Unit D of Section 32, Township 20 North, Range 9 West, NMPM. It was completed in the Mesaverde formation on June 17, 1972. The casing shoe is at 1,040 feet.

(3) That there is need for the creation of a new oil pool in McKinley County, New Mexico, for the production of oil from the Dakota formation, said pool to bear the designation of Blackeye-Dakota Oil Pool. Said Blackeye-Dakota Oil Pool was discovered by the Colorado Plateau Geological Services, Inc. No. 1 located in Unit M of Section 29, Township 20 North, Range 9 West, NMPM. It was completed in the Dakota formation on March 30, 1972. The top of the perforations is at 3,772 feet.

(4) That there is need for the creation of a new gas pool in McKinley County, New Mexico, for the production of gas from the Dakota A formation, said pool to bear the designation of Lone Pine-Dakota A Pool. Said Lone Pine-Dakota A Pool was discovered by Tenneco Oil Co. SFP RR No. 2 located in Unit L of Section 13, Township 17 North, Range 9 West, NMPM. It was completed in the Dakota A formation on September 10, 1970. The top of the perforations is at 2,547 feet.

(5) That there is need for the creation of a new gas pool in San Juan County, New Mexico, for the production of gas from the Fruitland formation, said pool to bear the designation of Mt. Nebo-Fruitland Pool. Said Mt. Nebo-Fruitland Pool was discovered by the Amoco Production Company Key Gas Com E No. 1 located in Unit D of Section 27, Township 32 North, Range 10 West, NMPM. It was completed in the Fruitland formation on February 22, 1972. The top of the perforations is at 2,402 feet.

(6) That there is need for certain extensions to the Hospah-Dakota Oil Pool and the Lone Pine-Dakota D Oil Pool both in Rio Arriba County, New Mexico, the Choza Mesa-Pictured Cliffs Pool, Gonzales-Mesaverde Pool, South Lindrith Gallup-Dakota Oil Pool, Otero-Chacra Pool and Tapacito-Pictured Cliffs Pool all in Rio Arriba County, New Mexico; Angels Peak-Gallup Oil Pool, Aztec-Pictured Cliffs Pool, Blanco-Pictured Cliffs Pool, Flora Vista-Fruitland Pool, South Gallegos-Fruitland Pool, North Los Pinos-Fruitland Pool, Pinon-Fruitland Pool, Tocito Dome-Pennsylvanian D Oil Pool, Ute Dome-Dakota Pool, Ute Dome-Paradox Pool and Kutz-Fruitland Pool all in San Juan County, New Mexico; and the Ballard-Pictured Cliffs Pool and South Blanco-Pictured Cliffs Pool both in Rio Arriba, Sandoval and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:

IT IS FURTHER ORDERED:

(1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Forms C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Commission within said 60-day period shall subject the well to cancellation of allowable.


(2) That the effective date of this order and all creations, extensions, and abolishments included herein shall be December 1, 1973.
