THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING AND EXTENDING VERTICAL AND HORIZONTAL LIMITS OF CERTAIN POOLS IN CHAVES, EDDY AND LEA COUNTIES, NEW MEXICO.

#### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9:00 a.m. on February 2, 1977, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 8th day of February, 1977, the Commission, a quorum being present, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the creation of a new gas pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Illinois Camp-Morrow Gas Pool. Said Illinois Camp-Morrow Gas Pool was discovered by the Yates Petroleum Corporation H-Y State GH Well No. 1 located in Unit K of Section 31, Township 18 South, Range 28 East, NMPM. It was completed in the Morrow formation on September 15, 1976. The top of the perforations is at 10,414 feet.
- (3) That there is need for the creation of a new gas pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of POW-Morrow Gas Pool. Said POW-Morrow Gas Pool was discovered by the Yates Petroleum Corporation State CK Com Well No. 1 located in Unit C of Section 4, Township 17 South, Range 26

East, NMPM. It was completed in the Morrow formation on July 27, 1973. The top of the perforations is at 7,963 feet.

- (4) That there is need for the creation of a new gas pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Revelation-Morrow Gas Pool. Said Revelation-Morrow Gas Pool was discovered by the Belco Petroleum Corporation Jones Com Well No. 1 located in Unit I of Section 9, Township 22 South, Range 25 East, NMPM. It was completed in the Morrow formation on September 17, 1976. The top of the perforations is at 10,385 feet.
- (5) That there is need for the creation of a new oil pool in Eddy County, New Mexico, for the production of oil from the Delaware formation, said pool to bear the designation of Southwest Sulphate-Delaware Pool. Said Southwest Sulphate-Delaware Pool was discovered by the Hanson Oil Corporation Gulf Federal Well No. 1 located in Unit M of Section 12, Township 25 South, Range 26 East, NMPM. It was completed in the Delaware formation on July 13, 1976. The top of the perforations is at 1,928 feet.
- (6) That there is need for the creation of a new oil pool in Lea County, New Mexico, for the production of oil from the Fusselman formation, said pool to bear the designation of Teague-Fusselman Pool. Said Teague-Fusselman Pool was discovered by the Carter Foundation Production Company E. C. Hill Federal Well No. 5 located in Unit E of Section 35, Township 23 South, Range 37 East, NMPM. It was completed in the Fusselman formation on December 3, 1976. The top of the perforations is at 8,069 feet.
- (7) That there is need for the creation of a new gas pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of North Turkey Track-Morrow Gas Pool. Said North Turkey Track-Morrow Gas Pool was discovered by the Hondo Drilling Company Alscott Well No. 1 located in Unit G of Section 31, Township 18 South, Range 29 East, NMPM. It was completed in the Morrow formation on July 6, 1976. The top of the perforations is at 11,079 feet.
- (8) That there is need for the extension of the vertical limits of the South Tonto-Yates Pool in Lea County, New Mexico, to include the Seven Rivers formation, redesignating said pool as the South Tonto Yates-Seven Rivers Pool, and the

extension of the horizontal limits of said South Tonto Yates-Seven Rivers Pool.

(9) That there is need for certain extensions to the Buffalo Valley-Pennsylvanian Gas Pool, Cato-San Andres Pool, the East Chisum-San Andres Pool, and the Many Gates-Abo Pool, all in Chaves County, New Mexico, and the Atoka-Pennsylvanian Gas Pool, the Avalon-Morrow Gas Pool, the Buffalo Valley-Pennsylvanian Gas Pool, the Burton Flat-Morrow Gas Pool, the South Carlsbad-Morrow Gas Pool, the Esperanza-Delaware Pool, the Little Box Canyon-Morrow Gas Pool, the South Loco Hills Queen-Grayburg-San Andres Pool, the Nash Draw-Atoka Gas Pool, the Red Lake-Pennsylvanian Gas Pool, the Scanlon-Morrow Gas Pool, and the Winchester-Morrow Gas Pool, all in Eddy County, New Mexico, and the Corbin-Queen Pool, the Cruz-Delaware Pool, the Hat Mesa-Morrow Gas Pool, the Kemnitz-Morrow Gas Pool, and the Tubb Gas Pool, all in Lea County, New Mexico.

#### IT IS THEREFORE ORDERED:

(a) That a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production, is hereby created and designated as the Illinois Camp-Morrow Gas Pool, consisting of the following described area:

(b) That a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production, is hereby created and designated as the POW-Morrow Gas Pool, consisting of the following described area:

(c) That a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production, is hereby created and designated as the Revelation-Morrow Gas Pool, consisting of the following described area:

(d) That a new pool in Eddy County, New Mexico, classified as an oil pool for Delaware production, is hereby created and

#### IT IS FURTHER ORDERED:

- (1) That, pursuant to Section 65-3-14.5, NMSA 1953, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Commission. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Commission within said 60-day period shall subject the well to cancellation of allowable.
- (2) That the effective date of this order and all creations and extensions included herein shall be March 1, 1977.
