ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on January 13, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 9th day of February, 1955, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the Ballard-Pictured Cliffs Pool in San Juan County and the Canyon Largo-Pictured Cliffs Pool in Rio Arriba County, New Mexico, should be created as advertised.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission of New Mexico be, and the same hereby is, approved as follows:

(a) That a new pool be created in San Juan County, New Mexico, classified as a gas pool for Pictured Cliffs production, designated as the Ballard-Pictured Cliffs Pool, and described as:
