DIVISION UPON ITS OWN MOTION FOR AN ORDER
CREATING, CONTRACTING VERTICAL LIMITS,
REDESIGNATING, AND EXTENDING CERTAIN POOLS
IN EDDY, LEA, AND ROOSEVELT COUNTIES,
NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on June 13, 1979,
at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 26th day of June, 1979, the Division
Director, having considered the testimony, the record, and the
recommendations of the Examiner, and being fully advised in the
premises,

FINDS:

(1) That due public notice having been given as required
by law, the Division has jurisdiction of this cause and the
subject matter thereof.

(2) That there is need for the creation of a new pool in
Eddy County, New Mexico, for the production of gas from the
Wolfcamp formation, said pool to bear the designation of Cass
Draw-Wolfcamp Gas Pool. Said Cass Draw-Wolfcamp Gas Pool was
discovered by the Black River Corporation Miller Com Well No. 1
located in Unit C of Section 10, Township 23 South, Range 27
East, NMPM. It was completed in the Wolfcamp formation on
October 10, 1978. The top of the perforations is at 9896 feet.

(3) That there is need for the creation of a new pool in
Eddy County, New Mexico, for the production of gas from the Abo
formation, said pool to bear the designation of Runyan Ranch-
Abo Gas Pool. Said Runyan Ranch-Abo Gas Pool was discovered by
the Mesa Petroleum Company Runyan Federal Com Well No. 1 located
in Unit E of Section 17, Township 19 South, Range 23 East, NMPM.
It was completed in the Abo formation on September 11, 1978.
The top of the perforations is at 4496 feet.

(4) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Morrow formation, said pool to bear the designation of Runyan Ranch-Morrow Gas Pool. Said Runyan Ranch-Morrow Gas Pool was discovered by the Mesa Petroleum Company Gardner State Well No. 1 located in Unit K of Section 8, Township 19 South, Range 23 East, NMPM. It was completed in the Morrow formation on January 6, 1979. The top of the perforations is at 7604 feet.

(5) That there is need for the contraction of the vertical limits of the Shoe Bar-Pennsylvanian Gas Pool in Lea County, New Mexico, to the Atoka formation only and the redesignation of said pool as the Shoe Bar-Atoka Gas Pool.

(6) That there is need for certain extensions to the Avalon-Morrow Gas Pool, the Avalon-Wolfcamp Gas Pool, the Burton Flat-Morrow Gas Pool, the South Culebra Bluff-Atoka Gas Pool, the Diamond Mound-Atoka Gas Pool, the Dublin Ranch-Morrow Gas Pool, the East Eagle Creek Atoka-Morrow Gas Pool, the South Empire-Morrow Gas Pool, the Herradura Bend-Delaware Pool, the Indian Flats-Morrow Gas Pool, the Kennedy Farms-Morrow Gas Pool, the East Lake-Morrow Gas Pool, the Logan Draw-Cisco Canyon Gas Pool, the West Malaga-Morrow Gas Pool, the Penasco Draw-Morrow Gas Pool, and the Turkey Track-Morrow Gas Pool, all in Eddy County, New Mexico, and the Austin-Mississippian Gas Pool, the Buffalo-Pennsylvanian Gas Pool, the Eumont Gas Pool, the Hardy-Blinebry Pool, the Shoe Bar-Atoka Gas Pool, the Teague-Abo Gas Pool, the West Tonto-Pennsylvanian Gas Pool, and the Wantz-Granite Wash Pool, all in Lea County, New Mexico, and the Chaveroo-San Andres Pool, the South Peterson-Fusselman Pool, the Todd-Wolfcamp Pool, and the Tomahawk-San Andres Pool, all in Roosevelt County, New Mexico.

IT IS THEREFORE ORDERED:

(a) That a new pool in Eddy County, New Mexico, classified as a gas pool for Wolfcamp production, is hereby created and designated as the Cass Draw-Wolfcamp Gas Pool, consisting of the following described area:

(b) That a new pool in Eddy County, New Mexico, classified as a gas pool for Abo production, is hereby created and designated as the Runyan Ranch-Abo Gas Pool, consisting of the following described area:

(c) That a new pool in Eddy County, New Mexico, classified as a gas pool for Morrow production, is hereby created and designated as the Runyan Ranch-Morrow Gas Pool, consisting of the following described area:

IT IS FURTHER ORDERED:

(1) That, pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which, by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations, contractions, extensions, and redesignations included herein shall be July 1, 1979.
