APPLICATION OF MORRIS R. ANTWEIL FOR AN UNORTHODOX GAS WELL LOCATION, LEA COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on September 5, 1979, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this 24th day of September, 1979, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Morris R. Antweil, seeks approval of an unorthodox gas well location 660 feet from the South line and 1980 feet from the East line of Section 5, Township 12 South, Range 32 East, NMPM, to test the Morrow formation, Lea County, New Mexico.
- (3) That the E/2 of said Section 5 is to be dedicated to the well.
- (4) That a well at said unorthodox location will better enable applicant to produce the gas underlying the proration unit.
- (5) That no offset operator objected to the proposed unorthodox location.
- (6) That approval of the subject application will afford the applicant the opportunity to produce its just and equitable share of the gas in the subject pool, will prevent the economic

loss caused by the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and will otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

- (1) That Morris R. Antweil is hereby granted an unorthodox gas well location for the Morrow formation for a well to be drilled at a point 660 feet from the South line and 1980 feet from the East line of Section 5, Township 12 South, Range 32 East, NMPM, Lea County, New Mexico.
- (2) That the E/2 of said Section 5 shall be dedicated to the above-described well.
- (3) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
