ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on May 18, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 18<sup>th</sup> day of June, 1955, the Commission, a quorum being present, having considered the testimony presented and the exhibits received in said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as prescribed by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That extension as advertised, and as further amended by testimony presented at the subject hearing, should be approved for the Aztec-Pictured Cliffs Gas Pool, San Juan County, New Mexico.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission of New Mexico be, and the same hereby is approved as follows:

(a) That the Aztec-Pictured Cliffs Gas Pool in San Juan County, New Mexico, as previously classified, defined and described, should be extended to include therein:

TOWNSHIP 28 NORTH, RANGE 9 WEST, NMPM  
All of partial Section 8;  
all of Section 17

TOWNSHIP 28 NORTH, RANGE 10 WEST, NMPM  
E/2 W/2 and E/2 of partial Section 11;  
W/2 of partial Section 12;  
SE/4 Section 13

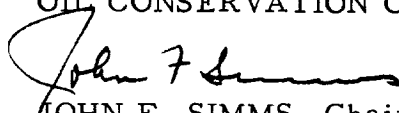
