ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on November 24, 1981, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 11th day of March, 1982, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Cities Service Company, seeks an order for downhole commingling and simultaneous dedication for the following five wells operated by Doyle Hartman:

Section 19, Township 24 South, Range 37 East:

Adele Sowell Well No. 1, Unit I
Adele Sowell Well No. 2, Unit P
Cities Thomas Well No. 1, Unit B
Cities Thomas Well No. 3, Unit H
Cities Thomas Well No. 4, Unit G

(3) That the matter came on for hearing at 9 a.m. on January 21, 1981, at Santa Fe, New Mexico, before the

(6) That the matter came on for rehearing on November 24, 1981.

(7) That applicant at said hearing requested that Case No. 7043 be dismissed.

(8) That Case No. 7043 should be dismissed.


IT IS THEREFORE ORDERED:

(1) That Case No. 7043 is hereby dismissed.


(2) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
