### ORDER OF THE COMMISSION


## BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on July 8, 1981, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 29th day of July, 1981, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Enserch Exploration, Inc., seeks an order to utilize its Rader Well No. 2, located in Unit E of Section 32, Township 5 South, Range 33 East, NMPM, South Peterson Field, Roosevelt County, New Mexico, to dispose of produced salt water into the Montoya formation, with injection into the perforated interval from approximately 7902 feet to 7930 feet.
- (3) That the matter came on for hearing at 9 a.m. on April 22, 1981, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter and, pursuant to this hearing, Order No. R-6685 was issued on May 20, 1981, which denied the application of Enserch.
- (4) That on June 16, 1981, application for Hearing  $\underline{\text{De Novo}}$  was made by Enserch Exploration, Inc. and the matter was set for hearing before the Commission.

- (5) That the matter came on for hearing  $\underline{\text{de novo}}$  on July 8, 1981.
- (6) That the evidence adduced at said hearing indicates that Division Order No. R-6685 entered May 20, 1981, should be affirmed.
