ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on August 17, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission, hereinafter referred to as the "Commission."

NOW, on this 15<sup>th</sup> day of September, 1955, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

- (1) That due notice having been given as prescribed by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That extensions as advertised should be approved for the Aztec-Pictured Cliffs Gas Pool, the Canyon Largo-Pictured Cliffs Gas Pool, and the Fulcher Kutz-Pictured Cliffs Gas Pool.
- (3) That extensions as advertised should be approved for the South Blanco-Pictured Cliffs Gas Pool with the following exception which should be continued to the regular September hearing:  
  
TOWNSHIP 27 NORTH, RANGE 9 WEST, NMPM  
Section 36: NE/4
- (4) That extensions as advertised should be approved for the Ballard-Pictured Cliffs Gas Pool with the following exception which should be continued to the regular September hearing:

Section 1: SW/4

which was erroneously advertised as follows:

(5) That the redesignation of the Hogback-Pennsylvanian Oil Pool as a gas pool should be approved as advertised.

IT IS THEREFORE ORDERED:

That the application of the Oil Conservation Commission upon its own motion be, and the same hereby is, approved as follows:

(a) That the Aztec-Pictured Cliffs Gas Pool, as heretofore classified, defined and described should be extended to include therein:

(b) That the Canyon Largo-Pictured Cliffs Gas Pool, as heretofore classified, defined and described should be extended to include therein:

(f) That the Hogback-Pennsylvanian Pool, previously designated as an oil pool, should be reclassified as a gas pool for the production of gas from the Pennsylvanian formation, and should be re-designated Hogback-Pennsylvanian Gas Pool, and described as:

Section 18: S/2

Section 19: All

Section 20: W/2

(g) That that portion of Section (d) of the advertisement for the subject hearing which pertains to the NE/4 of Section 36, Township 27 North, Range 9 West, NMPM, should be continued to the regular September hearing.

(h) That that portion of Section (e) of the advertisement for the subject hearing which pertains to the SE/4 of Section 1, Township 26 North, Range 9 West, NMPM, should be corrected to read SW/4 of Section 1, Township 26 North, Range 9 West, NMPM, and should be continued to the regular September hearing.
