ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on July 21, 1982,  
at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this 6th day of August, 1982, the Division  
Director, having considered the testimony, the record, and the  
recommendations of the Examiner, and being fully advised in the  
premises,

FINDS:

(1) That due public notice having been given as required  
by law, the Division has jurisdiction of this cause and the  
subject matter thereof.

(2) That there is need for the contraction of the Otero-  
Gallup Oil Pool in Rio Arriba County, New Mexico, by the dele-  
tion of certain acreage therefrom.

(3) That there is need for the creation of a new pool in  
Rio Arriba County, New Mexico, for the production of gas from  
the Chacra formation, said pool to bear the designation of Adobe-  
Chacra Pool. Said Adobe-Chacra Pool was discovered by the  
Cotton Petroleum Corporation Apache Well No. 26 located in Unit  
L of Section 13, Township 24 North, Range 4 West, NMPM. It was  
completed in the Chacra formation on February 25, 1981. The top  
of the perforations is at 3309 feet.

(4) That there is need for the creation of a new pool in  
San Juan County, New Mexico, for the production of oil from the

Gallup formation, said pool to bear the designation of Armenta-Gallup Oil Pool. Said Armenta-Gallup Oil Pool was discovered by the Amoco Production Company Harold B. Chapson Well No. 1 located in Unit J of Section 28, Township 29 North, Range 10 West, NMPM. It was completed in the Gallup formation on January 19, 1981. The top of the perforations is at 5315 feet.

(5) That there is need for the creation of a new pool in San Juan County, New Mexico, for the production of gas from the Fruitland formation, said pool to bear the designation of Glades-Fruitland Pool. Said Glades-Fruitland Pool was discovered by the Mesa Petroleum Company State Com S Well No. 15A located in Unit D of Section 36, Township 32 North, Range 12 West, NMPM. It was completed in the Fruitland formation on September 1, 1978. The top of the perforations is at 2806 feet.

(6) That there is need for the creation of a new pool in Sandoval County, New Mexico, for the production of oil from the Mancos formation, said pool to bear the designation of San Ysidro-Mancos Oil Pool. Said San Ysidro-Mancos Oil Pool was discovered by the Lewis Energy Corporation Ceja Pelon 29 Well No. 1 located in Unit M of Section 29, Township 21 North, Range 3 West, NMPM. It was completed in the Mancos formation on August 23, 1981. The top of the perforations is at 4560 feet.

(7) That there is need for certain extensions to the Albino-Pictured Cliffs Pool, the Angel Peak-Gallup Associated Pool, the Aztec-Fruitland Pool, the Aztec-Pictured Cliffs Pool, the Bisti-Farmington Pool, the Bisti-Lower Gallup Oil Pool, the Bloomfield-Chacra Pool, the Bloomfield-Farmington Oil Pool, the Cha Cha-Gallup Oil Pool, the Crouch Mesa-Mesaverde Pool, the Cuervo-Gallup Oil Pool, the Dufers Point Gallup-Dakota Oil Pool, the Farmer-Fruitland Pool, the Flora Vista-Fruitland Pool, the Flora Vista-Gallup Pool, the Fulcher Kutz-Pictured Cliffs Pool, the South Gallegos Fruitland-Pictured Cliffs Pool, the Gallegos-Gallup Oil Pool, the Harris Mesa-Chacra Pool, the Horseshoe-Gallup Oil Pool, the West Kutz-Pictured Cliffs Pool, the North Los Pinos-Fruitland Pool, the South Los Pinos Fruitland-Pictured Cliffs Pool, the Meadows-Gallup Oil Pool, the Mt. Oil Pool, the Otero-Chacra Pool, the Otero-Gallup Oil Pool, and the Wildhorse-Gallup Pool, all in Rio Arriba County, New Mexico, and the Ballard-Pictured Cliffs Pool, the Blanco-Pictured Cliffs Pool, and the South Blanco-Pictured Cliffs Pool, all in Rio Arriba, Sandoval, and San Juan Counties, New Mexico, and the Blanco-Mesaverde Pool and the Largo-Chacra Pool, both in Rio Arriba and San Juan Counties, New Mexico, and the Chacon-Dakota Associated Pool and the Lybrook-Gallup Oil Pool, both in Rio Arriba and Sandoval Counties, New Mexico, and the Hospah-Dakota Oil Pool, the Marcelina-Dakota Oil Pool, and the Miguel Creek-Gallup Oil Pool, all in McKinley County, New Mexico.


IT IS FURTHER ORDERED:

(1) That pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a non-standard unit approved by the Division within said 60-day period shall subject the well to cancellation of the allowable.

(2) That the effective date of this order and all creations, contractions, and extensions included herein shall be August 1, 1982.
