THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING, ASSIGNING DISCOVERY ALLOWABLES, CONTRACTING, AND EXTENDING CERTAIN POOLS IN CHAVES, EDDY, LEA, AND ROOSEVELT COUNTIES, NEW MEXICO.

#### ORDER OF THE DIVISION

### BY THE DIVISION:

This cause came on for hearing at 9 a.m. on October 13, 1982, at Santa Fe, New Mexico, before Examiner Daniel S. Nutter.

NOW, on this <u>19th</u> day of October, 1982, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Cherry Canyon formation, said pool to bear the designation of Antelope Ridge-Cherry Canyon Pool. Further, that there is need for the assignment of a discovery allowable of 34,590 barrels to the discovery well, the Estoril Production Corporation Triple A Federal Well No. 2 located in Unit J of Section 10, Township 23 South, Range 34 East, NMPM. It was completed in the Cherry Canyon formation on May 30, 1982. The top of the perforations is at 6,734 feet.

(3) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of oil from the Cherry Canyon formation, said pool to bear the designation of Brushy Draw-Cherry Canyon Pool. Further, that there is need -2-Case No. 7702 Order No. R-7114

for the assignment of a discovery allowable of 25,410 barrels to the discovery well, the J. C. Williamson UCBHWW Federal Well No. 1 located in Unit M of Section 25, Township 26 South, Range 29 East, NMPM. It was completed in the Cherry Canyon formation on June 23, 1982. The top of the perforations is at 5,082 feet.

(4) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the Pennsylvanian formation, said pool to bear the designation of West Buffalo Valley-Pennsylvanian Gas Pool. Said West Buffalo Valley-Pennsylvanian Gas Pool was discovered by the Clements Energy, Inc. Drumm Com Well No. 1 located in Unit E of Section 33, Township 14 South, Range 26 East, NMPM. It was completed in the Pennsylvanian formation on June 18, 1982. The top of the perforations is at 6,678 feet.

(5) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Wolfcamp formation, said pool to bear the designation of North Grama Ridge-Wolfcamp Gas Pool. Said North Grama Ridge-Wolfcamp Gas Pool was discovered by the HNG Oil Company San Simon 19 State Well No. 1 located in Unit J of Section 19, Township 21 South, Range 35 East, NMPM. It was completed in the Wolfcamp formation on July 26, 1982. The top of the perforations is at 10,858 feet.

(6) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of gas from the Yates and Seven Rivers formations, said pool to bear the designation of South House Yates-Seven Rivers Gas Pool. Said South House Yates-Seven Rivers Gas Pool was discovered by the Alpha Twenty-One Production Company Colvin Federal Well No. 1 located in Unit B of Section 17, Township 20 South, Range 39 East, NMPM. It was completed in the Yates and Seven Rivers formations on June 2, 1982. The top of the perforations is at 2,889 feet.

(7) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Devonian formation, said pool to bear the designation of McDonald-Devonian Pool. Said McDonald-Devonian Pool was discovered by the Harvey E. Yates Company McDonald Unit Well No. 2 located in Unit D of Section 3, Township 14 South, Range 36 East, NMPM. It was completed in the Devonian formation on July 8, 1982. The top of the perforations is at 14,556 feet.

(8) That there is need for the creation of a new pool in Chaves County, New Mexico, for the production of gas from the

Pennsylvanian formation, said pool to bear the designation of Palma Mesa-Pennsylvanian Gas Pool. Said Palma Mesa-Pennsylvanian Gas Pool was discovered by the Rault Petroleum Corporation Hanlad State Well No. 1 located in Unit M of Section 13, Township 8 South, Range 27 East, NMPM. It was completed in the Pennsylvanian formation on July 8, 1982. The top of the perforations is at 6,327 feet.

(9) That there is need for the contraction of the Bar U-Pennsylvanian Pool in Chaves County, New Mexico, in order to correct an overlap with the Tobac-Pennsylvanian Pool.

(10) That there is need for certain extensions to the Cato-San Andres Pool, the Diamond Mound Atoka-Morrow Gas Pool, the Linda-San Andres Pool, the Pecos Slope-Abo Gas Pool, and the Tower-San Andres Pool, all in Chaves County, New Mexico, and the Carlsbad-Strawn Gas Pool, the Empire-Abo Pool, the Indian Flats-Morrow Gas Pool, the North Loving-Morrow Gas Pool, the Sandpoint-Atoka Gas Pool, and the Turkey Track Seven Rivers-Queen-Grayburg Pool, all in Eddy County, New Mexico, and the Austin-Mississippian Gas Pool, the Blinebry Oil and Gas Pool, the Bootleg Ridge-Morrow Gas Pool, the Buckeye-Abo Pool, the Buffalo-Pennsylvanian Gas Pool, the South Corbin-Wolfcamp Pool, the EK-Bone Spring Pool, the East Gem-Morrow Gas Pool, the East Grama Ridge-Morrow Gas Pool, the Hat Mesa-Morrow Gas Pool, the South Kemnitz-Atoka Gas Pool, the Langlie Mattix Seven Rivers-Queen-Grayburg Pool, the Lovington-Abo Pool, the Maljamar Grayburg-San Andres Pool, and the Vada-Pennsylvanian Pool, all in Lea County, New Mexico, and the Tomahawk-San Andres Pool in Roosevelt County, New Mexico.

#### IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as an oil pool for Cherry Canyon production is hereby created and designated as the Antelope Ridge-Cherry Canyon Pool, consisting of the following described area:

Further, that the discovery well for said Antelope Ridge-Cherry Canyon Pool, being the Estoril Production Corporation Triple A Federal Well No. 2 located in Unit J of Section 10, Township 23 South, Range 34 East, NMPM, is hereby assigned a bonus discovery allowable in the amount of 34,590 barrels to be produced over a two-year period. -4-Case No. 7702 Order No. R-7114

(b) That a new pool in Eddy County, New Mexico, classified as an oil pool for Cherry Canyon production is hereby created and designated as the Brushy Draw-Cherry Canyon Pool, consisting of the following described area:

Further, that the discovery well for said Brushy Draw-Cherry Canyon Pool, being the J. C. Williamson UCBHWW Federal Well No. 1 located in Unit M of Section 25, Township 26 South, Range 29 East, NMPM, is hereby assigned a bonus discovery allowable in the amount of 25,410 barrels to be produced over a two-year period.

(c) That a new pool in Chaves County, New Mexico, classified as a gas pool for Pennsylvanian production is hereby created and designated as the West Buffalo Valley-Pennsylvanian Gas Pool, consisting of the following described area:

## IT IS FURTHER ORDERED:

(1) That pursuant to Section 70-2-18, NMSA 1978, contained in Chapter 271, Laws of 1969, any well which by virtue of any of the above pool extensions, is subject to pool rules providing for spacing or proration units larger than the one which is presently dedicated thereto, shall have 60 days from the effective date of this order in which to file new Forms C-102 dedicating a standard unit for the pool to said well, or to obtain a non-standard unit approved by the Division. Pending such compliance, the well shall receive a maximum allowable in the same proportion to a standard allowable for the pool that the acreage dedicated to the well bears to a standard unit for the pool. Failure to file Form C-102 dedicating a standard unit to the well or to obtain a nonstandard unit approved by the Division within said 60-day period shall subject the well to cancellation of allowable.

(2) That the effective date of this order and all creations, discovery allowable assignments, contractions, and extensions included herein shall be November 1, 1982.
