ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on January 5, 1983, at Santa Fe, New Mexico, before Examiner Michael E. Stogner.

NOW, on this 25th day of January, 1983, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, C & E Operators, Inc., is the owner and operator of the Aztec Well No. 8, located in Unit M of Section 8, Township 30 North, Range 11 West, NMPM, San Juan County, New Mexico.

(3) That the applicant seeks authority to commingle Farmer-Fruitland and Aztec-Pictured Cliffs production within the wellbore of the above-described well.

(4) That from the Farmer-Fruitland zone, the subject well is capable of low marginal production only.

(5) That from the Aztec-Pictured Cliffs zone, the subject well is capable of low marginal production only.

(6) That the proposed commingling may result in the recovery of additional hydrocarbons from each of the subject pools, thereby preventing waste, and will not violate correlative rights.

(7) That the reservoir characteristics of each of the subject zones are such that underground waste would not be caused by the proposed commingling provided that the well is not shut-in for an extended period.

(8) That to afford the Division the opportunity to assess the potential for waste and to expeditiously order appropriate remedial action, the operator should notify the Aztec district office of the Division any time the subject well is shut-in for 7 consecutive days.

(9) That in order to allocate the commingled production to each of the commingled zones in the subject well, 68 percent of the commingled gas production should be allocated to the Pictured Cliffs zone, and 32 percent of the commingled gas production to the Fruitland zone.

IT IS THEREFORE ORDERED:

(1) That the applicant, C & E Operators, Inc., is hereby authorized to commingle Farmer-Fruitland and Aztec-Pictured Cliffs production within the wellbore of the Aztec Well No. 8, located in Unit M of Section 8, Township 30 North, Range 11 West, NMPM, San Juan County, New Mexico.

(2) That 68 percent of the commingled gas production shall be allocated to the Pictured Cliffs zone and 32 percent of the commingled gas production shall be allocated to the Fruitland zone.

(3) That the operator of the subject well shall immediately notify the Division's Aztec district office any time the well has been shut-in for 7 consecutive days and shall concurrently present, to the Division, a plan for remedial action.

(4) That jurisdiction of this cause is retained for the entry of such further orders as the Division may deem necessary.
