APPLICATION OF AMOCO PRODUCTION
COMPANY FOR DIRECTIONAL DRILLING
AND AN UNORTHODOX LOCATION, EDDY
COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 9 a.m. on August 17, 1983, at Santa Fe, New Mexico, before Examiner Richard L. Stamets.

NOW, on this 23rd day of August, 1983, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.

(2) That the applicant, Amoco Production Company, is the owner and operator of the State "IB" Com Well No. 1, the surface location of which is 660 feet from the South line and 1980 feet from the West line of Section 31, Township 23 South, Range 25 East, Eddy County, New Mexico.

(3) That the applicant seeks to directionally drill said well by kicking off from the vertical at the approximate casing cutoff point (between 5,000 and 8,000 feet) and drilling directionally to a bottom hole location within 100 feet of a point located 872 feet from the South line and 2,192 feet from the West line of said Section 31.

(4) That the S/2 of said Section 31 should be dedicated to the well.

(5) That the applicant should be required to determine the subsurface location of the bottom of the hole by means of a continuous multi-shot directional survey conducted subsequent to said directional drilling, if said well is to be completed as a producing well.

(6) That approval of the subject application will prevent the drilling of unnecessary wells, avoid the augmentation of risk arising from the drilling of an excessive number of wells, and otherwise prevent waste and protect correlative rights.

IT IS THEREFORE ORDERED:

(1) That the applicant, Amoco Production Company, is hereby authorized to directionally drill its State "IB" Com Well No. 1 from a surface location 660 feet from the South line and 1980 feet from the West line of Section 31, Township 23 South, Range 25 East, by kicking off from the vertical at a depth of between 5,000 and 8,000 feet and drilling in such a manner as to penetrate the Morrow formation at a bottom hole location within 100 feet of a point located 872 feet from the South line and 2192 feet from the West line of said Section 31.

PROVIDED HOWEVER, that prior to the above-described directional drilling, the applicant shall establish the location of the kick-off point by conducting a continuous multi-shot directional survey of the well.

PROVIDED FURTHER, that subsequent to the above-described directional drilling, should said well be a producer, a continuous multi-shot directional survey shall be made of the wellbore from total depth to the kick-off point with shot points not more than 100 feet apart; the operator shall cause the surveying company to forward a copy of the survey report directly to the Santa Fe office of the Division, P. O. Box 2088, Santa Fe, New Mexico 87501, and that the operator shall notify the Division's Hobbs District Office of the date and time said survey is to be commenced.

(2) That Form C-105 shall be filed in accordance with Division Rule 1105 and the operator shall indicate thereon true vertical depth in addition to measured depths.


(3) That the S/2 of said Section 31 shall be dedicated to the subject well.
