DELETION, REDESIGNATION AND ABOLISHMENT
OF CERTAIN POOLS IN LEA, EDDY, AND CHAVES
COUNTIES, NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m., on December 14, 1955, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 12th day of January 1956, the Commission, a quorum being present, having considered the testimony presented, and the exhibits received at said hearing, and being fully advised in the premises,

FINDS:

1. That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
2. That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Bone Spring formation, said pool to bear the designation Bell Lake-Bone Spring Pool. Said Bell Lake-Bone Spring Pool was discovered by Continental Oil Company, Bell Lake Unit #3, located in NE/4 NW/4, Section 6, Township 24 South, Range 34 East, NMPM. It was completed August 22, 1955. The top of the perforations is at 8670 feet.
3. That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the San Andres formation, said pool to bear the designation E-K San Andres Pool. Said E-K San Andres Pool was discovered by Plateau Oil Company, British-American State #1, located in NE/4 SE/4, Section 12, Township 18 South, Range 33 East, NMPM. It was completed October 10th, 1955. The top of the perforations is at 5062 feet.
4. That there is need for certain extensions to the Allison-Pennsylvanian Pool, the Anderson Ranch-Wolfcamp Pool, the Bronco-Wolfcamp Pool, the Corbin-Queen Pool, the Denton-Wolfcamp Pool, the Eidson-Pennsylvanian Pool, the E-K Queen Pool, the Gladiola Pool, the Jalmat Gas Pool, the Maljamar Pool, the Warren-Drinkard Pool, the Blinebry Oil Pool, the Eumont Gas Pool, the Tubb Gas Pool, and the Blinebry Gas Pool, all in Lea County, New Mexico, the Caprock-Queen Pool in Chaves County, New Mexico, and the Grayburg-Keely Pool and the Loco Hills Pool, both in Eddy County, New Mexico.
5. That there is need for the deletion of certain areas from the Terry-Blinebry Pool in Lea County, New Mexico.
6. That there is need for the reclassification and redesignation of the Elliott Pool in Lea County, New Mexico, presently defined as an oil pool for Drinkard production, as an oil pool for Abo production, said pool to be designated the Elliott-Abo Pool.

7. That there is need for the abolishment of the East Maljamar Pool in Lea County, New Mexico.

8. That the subject of the deletion of certain areas from the Bagley-Pennsylvanian Pool in Lea County, New Mexico, should be deferred for further study.

IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as an oil pool for Bone Spring production, be and the same hereby is created. Said pool is hereby designated as the Bell Lake-Bone Spring Pool and consists of the following described area:

(b) That a new pool in Lea County, New Mexico, classified as an oil pool for San Andres Production be and the same hereby is created. Said pool is hereby designated as the E-K San Andres Pool and consists of the following described area:

(c) That the Allison-Pennsylvanian Pool in Lea County, New Mexico as heretofore classified, defined and described, be and the same is hereby extended to include therein:


