ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8 a.m. on February 29, 1984, and on March 14, 1984, at Santa Fe, New Mexico, before Examiners Michael E. Stogner and Richard L. Stamets, respectively.

NOW, on this 15th day of March, 1984, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS:

- (1) That due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Anadarko Production Company, is the operator of the Burnham GSA Unit Waterflood Project, approved by Division Order No. R-4610, dated August 24, 1973, Square Lake Grayburg-San Andres Pool, Eddy County, New Mexico.
- (3) That the applicant seeks approval of five unorthodox oil well locations to be drilled as producing oil wells in said Burnham GSA Unit Waterflood Project, all in Section 2, Township 17 South, Range 30 East, NMPM, Square Lake Grayburg-San Andres Pool, Eddy County, New Mexico, as follows:

- (4) That the quarter-quarter section wherein any of said wells is located in said Section 2 is to be dedicated to such well.
- (5) That no offset operator objected to the proposed unorthodox locations.
- (6) That approval of the subject application should provide an efficient oil production pattern in the aforesaid Burnham GSA Unit Waterflood Project and result in the recovery of otherwise unrecoverable oil, thereby preventing waste.

IT IS THEREFORE ORDERED:

(1) That the application of Anadarko Production Company for five unorthodox oil well locations to be drilled as producing oil wells in the Burnham GSA Unit Waterflood Project is hereby approved, said wells all to be located in Section 2, Township 17 South, Range 30 East, NMPM, Square Lake Grayburg-San Andres Pool, Eddy County, New Mexico, as follows:
