APPLICATION OF CONOCO INC. FOR A NON-STANDARD GAS PRORATION UNIT AND SIMULTANEOUS DEDICATION, LEA COUNTY, NEW MEXICO.

#### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 a.m. on March 29, 1984, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this <u>30th</u> day of April, 1984, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing, and being fully advised in the premises,

## FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That the applicant, Conoco Inc., is the operator of two currently approved non-standard proration units in the Jalmat Gas Pool as follows:

# TOWNSHIP 25 SOUTH, RANGE 37 EAST, NMPM

- (a) E/2 NW/4 and W/2 NE/4 of Section 19 consisting of 160 acres dedicated to its Sholes B-19 Well No. 2 located in Unit C and;
- (b) E/2 SW/4 and W/2 SE/4 of Section 19 consisting of 160 acres dedicated to its Sholes B-19 Well No. 4 located in Unit K.

- (3) That applicant seeks approval to consolidate the two said non-standard proration units into a single 320-acre non-standard proration unit comprising the  $\rm E/2~W/2$  and  $\rm W/2~E/2$  of said Section 19 and for the simultaneous dedication of the unit to the two said Wells Nos. 2 and 4.
- (4) That in Case No. 8078, Doyle Hartman sought to form a 480-acre non-standard proration unit with simultaneous dedication to several wells, said non-standard unit being to the south and east of applicant's proposed non-standard unit.
- (5) That Cases Nos. 8096 and 8078 were consolidated for the purpose of obtaining testimony.
- (6) That the formation of applicant's non-standard unit was opposed by Doyle Hartman.
- (7) That Doyle Hartman failed to prove that his correlative rights would be violated or waste would occur if the application of Conoco was approved.
- (8) That the entire proposed 320-acre non-standard proration unit is productive of gas from the Jalmat Gas Pool and that such unit can be efficiently and economically drained by the wells proposed or currently producing thereon.
  - (9) That the application in this case should be approved.

## IT IS THEREFORE ORDERED:

- (1) That the application of Conoco Inc. to form a 320-acre non-standard gas proration unit comprising the E/2 W/2 and W/2 E/2 of Section 19, Township 25 South, Range 37 East, NMPM, Lea County, New Mexico, and for the simultaneous dedication of the unit to the Sholes B-19 Well No. 2 and the Sholes B-19 Well No. 4 located in Units C and K, respectively, Jalmat Gas Pool, is hereby approved.
- (2) That jurisdiction of this cause is retained for the entry of such further orders as the Commission may deem necessary.
