ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m.
on September 13, 1956, at Santa Fe, New Mexico, before the Oil
Conservation Commission of New Mexico, hereinafter referred to
as the "Commission."

NOW, on this *26th* day of October, 1956, the Commission,
a quorum being present, having considered the testimony presented
and the exhibits received at said hearing, and being fully advised
in the premises,

FINDS:

(1) That due public notice having been given as required
by law, the Commission has jurisdiction of this cause and the subject
matter thereof.

(2) That there is need for certain extensions to the
East Companero-Dakota Pool, the Canyon Largo-Pictured Cliffs Pool,
the East Blanco-Pictured Cliffs Pool, the Otero-Pictured Cliffs
Pool, and the Tapicito-Pictured Cliffs Pool, all in Rio Arriba
County, New Mexico, the Aztec-Pictured Cliffs Pool, the Fulcher
Kutz-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, and
the Bisti-Lower Gallup Oil Pool, all in San Juan County, New Mexico,
and the Ballard-Pictured Cliffs Pool and the South Blanco-Pictured
Cliffs Pool, both in Rio Arriba and San Juan Counties, New Mexico.

IT IS THEREFORE ORDERED:




