ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on October 17, 1956, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission".

NOW, on this 20 day of November, 1956, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Baum-Wolfcamp Pool, the Crosby-Devonian Gas Pool, the E-K Queen Pool, the Eumont Gas Pool, and the King-Devonian Pool, all in Lea County, New Mexico, and to the Caprock-Queen Pool in Lea and Chaves Counties, New Mexico.

(3) That the proposed extension to the Jalmat Gas Pool in Lea County, New Mexico, should be dismissed due to an error in the legal advertisement of the proposed extension.

IT IS THEREFORE ORDERED:

(a) That the Baum-Wolfcamp Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(b) That the Caprock-Queen Pool in Lea and Chaves Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(c) That the Crosby-Devonian Gas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(d) That the E-K Queen Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(e) That the Eumont Gas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

(g) That the King-Devonian Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:


