#### FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this case and the subject matter thereof.
- (2) That Atlantic Refining Company entered an appearance and introduced evidence to prove that the existing system of allocation in the Denton (Devonian) Pool is not resulting in waste.
- (3) That said allocation system is not resulting in waste and should be continued in effect.
- (4) That Atlantic Refining Company, by its attorney, moved without objection for dismissal of the cause.
  - (5) That said cause should therefore be dismissed.

# IT IS THEREFORE ORDERED:

1. That the application of the Oil Conservation Commission upon its own motion for an order establishing the maximum efficient production rate for the Denton (Devonian) Pool, Lea County, New Mexico, be and the same is hereby dismissed.

### ORDER OF THE COMMISSION

#### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on December 13, 1956, and at 9 o'clock a.m. January 16, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this  $30^{th}$  day of January, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

## FINDS:

- (1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.
- (2) That there is need for the abolishment of the Hardy Pool in Lea County, New Mexico.
- (3) That there is need for certain extensions to the Eumont Gas Pool and the Penrose-Skelly Pool, both in Lea County, New Mexico.

### IT IS THEREFORE ORDERED:

(a) That the Hardy Pool in Lea County, New Mexico, as heretofore classified, defined, and described, consisting of the following described area:

TOWNSHIP 20 SOUTH, RANGE 38 EAST, NMPM All Section 31

be and the same is hereby abolished.

(b) That the Eumont Gas Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:

TOWNSHIP 20 SOUTH, RANGE 37 EAST, NMPM Section 25: NW/4 and S/2

Section 36: E/2

TOWNSHIP 20 SOUTH, RANGE 38 EAST, NMPM Section 31: All

(c) That the Penrose-Skelly Pool in Lea County, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
