THE APPLICATION OF THE OIL CONSERVATION DIVISION UPON ITS OWN MOTION FOR AN ORDER CREATING AND ASSIGNING DISCOVERY ALLOWABLES TO CERTAIN POOLS IN LEA COUNTY, NEW MEXICO.

ORDER OF THE DIVISION

BY THE DIVISION:

This cause came on for hearing at 8:15 a.m. on May 16 and June 13, 1991, before Examiners David R. Catanach and Michael E. Stogner, respectively.

NOW, on this 24th day of June, 1991, the Division Director, having considered the testimony, the record, and the recommendations of the Examiner, and being fully advised in the premises,

FINDS THAT:

- (1) Due public notice having been given as required by law, the Division has jurisdiction of this cause and the subject matter thereof.
- (2) There is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Wolfcamp formation, said pool to bear the designation of South Shoe Bar-Wolfcamp Pool. Further, the discovery well for said South Shoe Bar-Wolfcamp Pool, the Mobil Exploration and Producing US Inc. Lovington Deep State Well No. 3 located in Unit G of Section 1, Township 17 South, Range 35 East, NMPM, is entitled to and should receive a bonus discovery allowable, retroactive to the date of completion, in the amount of 51,240 barrels of oil to be assigned over a two-year period. Said discovery well was completed in the Wolfcamp formation on January 26, 1991. The top of the perforations is at 10,248 feet.

(3) There is need for the assignment of a discovery allowable to the discovery well for the Geronimo-Delaware Pool in Lea County, New Mexico, the Mitchell Energy Corporation Geronimo Federal Well No. 1 located in Unit D of Section 31, Township 19 South, Range 33 East, NMPM. Said discovery well is entitled to and should receive a bonus discovery allowable in the amount of 37,930 barrels of oil to be assigned over a two-year period. Said Geronimo-Delaware Pool was created by Division Order No. R-9447, effective March 1, 1991.

IT IS THEREFORE ORDERED THAT:

(a) Effective January 26, 1991, a new pool in Lea County, New Mexico, classified as an oil pool for Wolfcamp production is hereby created and designated as the South Shoe Bar-Wolfcamp Pool, consisting of the following described area:

TOWNSHIP 17 SOUTH, RANGE 35 EAST, NMPM Section 1: NE/4

Further, the discovery well for said South Shoe Bar-Wolfcamp Pool, the Mobil Exploration and Producing US Inc. Lovington Deep Unit Well No. 3 located in Unit G of Section 1, Township 17 South, Range 35 East, NMPM, is hereby assigned a bonus discovery allowable, retroactive to January 26, 1991, in the amount of 51,240 barrels of oil to be assigned over a two-year period.

(b) Effective May 1, 1991, the discovery well for the Geronimo-Delaware Pool in Lea County, New Mexico, the Mitchell Energy Corporation Geronimo Federal Well No. 1 located in Unit D of Section 31, Township 19 South, Range 33 East, NMPM, is hereby assigned a bonus discovery allowable in the amount of 37,930 barrels of oil to be assigned over a two-year period.
