ORDER OF THE COMMISSION

BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on February 14, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 8th day of March, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for certain extensions to the Canyon Largo-Pictured Cliffs Pool in Rio Arriba County, New Mexico, the Fulcher Kutz-Pictured Cliffs Pool, the West Kutz-Pictured Cliffs Pool, the Bisti-Lower Gallup Oil Pool, and the Verde-Gallup Oil Pool, all in San Juan County, New Mexico, and the Ballard-Pictured Cliffs Pool, the South Blanco-Pictured Cliffs Pool, and the Blanco-Mesaverde Pool, all in San Juan and Rio Arriba Counties, New Mexico.
