THE APPLICATION OF THE OIL CONSERVATION COMMISSION UPON ITS OWN MOTION FOR AN ORDER CREATING, EXTENDING, AND ABOLISHING CERTAIN POOLS IN LEA, CHAVES, AND EDDY COUNTIES, NEW MEXICO.

#### ORDER OF THE COMMISSION

### BY THE COMMISSION:

This cause came on for hearing at 9 o'clock a.m. on April 17, 1957, at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this  $29^{t_1}$  day of April, 1957, the Commission, a quorum being present, having considered the testimony presented and the exhibits received at said hearing and being fully advised in the premises,

#### FINDS:

(1) That due public notice having been given as required by law, the Commission has jurisdiction of this cause and the subject matter thereof.

(2) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Pennsylvanian formation, said pool to bear the designation East Anderson Ranch-Pennsylvanian Pool. Said East Anderson Ranch-Pennsylvanian Pool was discovered by Humble Oil & Refining Company, New Mexico State AQ #1, located in Lot 9, Section 3, Township 16 South, Range 33 East, NMPM. It was completed February 20, 1957. The top of the perforations is at 10,960 feet.

(3) That there is need for the creation of a new pool in Lea County, New Mexico, for the production of oil from the Drinkard formation, said pool to bear the designation Arrowhead-Drinkard Pool. Said Arrowhead-Drinkard Pool was discovered by Gulf Oil Corporation Harry Leonard "C" #10, located in the SE/4 SW/4 Section 36, Township 21 South, Range 36 East, NMPM. It was completed February 1, 1957. The top of the perforations is at 6,555 feet.

(4) That there is need for the creation of a new pool in Eddy County, New Mexico, for the production of gas from the Pennsylvanian formation, said pool to bear the designation Red Lake-Pennsylvanian Gas Pool. Said Red Lake-Pennsylvanian Gas Pool was discovered by Humble Oil & Refining Company, Chalk Bluff Draw Unit #1, located -2-Case No. 1238 Order No. R-986

in the NE/4 SW/4 Section 5, Township 18 South, Range 27 East, NMPM. It was completed April 13, 1956. The top of the perforations is at 9,443 feet.

(5) That there is need for certain extensions to the Corbin Pool, the Crosby-Devonian Gas Pool, the Eumont Gas Pool, the North Gladiola-Devonian Pool, the Jalmat Gas Pool, the Langlie-Mattix Pool, the Lea Pool, the North Shoe-Bar Devonian Pool, the Warren-McKee Pool, and the Young Pool, all in Lea County, New Mexico, to the Caprock-Queen Pool in Lea and Chaves Counties, New Mexico, and to the Empire-Wolfcamp Pool, the West Henshaw-Grayburg Pool, and the Square Lake Pool, all in Eddy County, New Mexico. Further, that there is need for certain extensions to the vertical limits of the Shugart Pool in Eddy County, New Mexico, and for the abolishment of the Shugart-Grayburg Pool in Eddy County, New Mexico.

# IT IS THEREFORE ORDERED:

(a) That a new pool in Lea County, New Mexico, classified as an oil pool for Pennsylvanian production, be and the same is hereby created and designated as the East Anderson Ranch-Pennsylvanian Pool consisting of the following described area:

> TOWNSHIP 16 SOUTH, RANGE 33 EAST, NMPM Section 3: Lots 7, 8, 9, and 10

(b) That a new pool in Lea County, New Mexico, classified as an oil pool for Drinkard production, be and the same is hereby created and designated as the Arrowhead-Drinkard Pool, consisting of the following described area:

## TOWNSHIP 21 SOUTH, RANGE 36 EAST, NMPM Section 36: SW/4

(c) That a new pool in Eddy County, New Mexico, classified as a gas pool for Pennsylvanian production, be and the same is hereby created and designated as the Red Lake-Pennsylvanian Gas Pool, consisting of the following described area:

(d) That the Caprock-Queen Pool in Lea and Chaves Counties, New Mexico, as heretofore classified, defined, and described, be and the same is hereby extended to include therein:
