ORDER OF THE COMMISSION

BY THE COMMISSION:

This matter came on for hearing at 10:00 o'clock a. m. on the 21st day of February, 1950 at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

Pursuant to notice duly given and the Commission having considered the evidence,

FINDS:

1. That it has jurisdiction of this cause and that due public notice has been given.
2. That it is necessary to extend the boundaries of the hereinafter named oil pools in order to include in such pools as extended the presently proved limits of the respective common reservoirs, and that such pool extensions are reasonable.

IT IS THEREFORE ORDERED:

That the hereinafter named oil pools are extended as follows:

- (1) Extend the Empire Pool to include the S 1/2 section 12, N 1/2 section 13, T. 17 S, R. 27 E; and N 1/2 section 18, T. 17 S, R. 28 E, NMPM, for Seven Rivers production, Eddy County, New Mexico.
- (2) Extend the Turkey Track - Queen Pool to include the S 1/2 section 10, N 1/2 section 15, T. 19 S, R. 29 E, NMPM, for Queen production, Eddy County, New Mexico.
- (3) Extend the Loco Hills Pool to include all of section 12, T. 18 S, R. 28 E, NMPM, for Grayburg production, Eddy County, New Mexico.
- (4) Extend the Hare pool to include the E 1/2 section 29, T. 21 S, R. 37 E, NMPM, for Simpson Sand production, Lea County, New Mexico.
- (5) Extend the House pool to include the N 1/2 and SE 1/4 section 1, T. 20 S, R. 38 E; and all of Section 6, T. 20 S, R. 39 E, NMPM, for lower Leonard (Permian) production, Lea County, New Mexico.
- (6) Extend the Young Pool to include the NE 1/4 section 19, T. 18 S, R. 32E, NMPM, for Queen production, Lea County, New Mexico.

(7) Extend the West Lovington pool to include the E/2 section 12, T. 17 S, R. 35E; and SW/4 section 7, T. 17S, R. 36E, NMPM, for San Andres production, Lea County, New Mexico.

(8) Extend the North Drinkard pool to include SW/4 section 3, T. 21S, R. 37 E, NMPM, for Drinkard production, Lea County, New Mexico.

(9) Extend the Langlie Mattix pool to include all of sections 3 and 10, T. 23S, R. 36 E, NMPM, for Yates production, Lea County, New Mexico.

(10) Extend the Brunson pool to include the SW/4 section 22, T. 21S, R. 37E, NMPM, for Ellenburger production, Lea County, New Mexico, and to classify each named pool as so extended as an oil pool.
