NEW MEXICO.

ORDER OF THE COMMISSION

BY THE COMMISSION:

THIS matter came on for hearing this 7th day of August, 1951, at 10:00 a. m. at Santa Fe, New Mexico, before the Oil Conservation Commission of New Mexico, hereinafter referred to as the "Commission."

NOW, on this 15th day of October, 1951, the Commission a quorum being present, considered the testimony adduced relating to the various matters in said cause, and being fully advised in the premises,

FINDS, (1) That due notice of publication having been given in accordance with law, the Commission has jurisdiction of the cause and of the matters and things relating thereto.

(2) That the boundaries of the North Brunson (Ellenburger) pool, as heretofore established and described, should be changed to include Lots 11, 12, 13, and 14 of section 2, and Lots 9, 10, 15, and 16 of section 3, in Township 21 South, Range 37 East, N.M.P.M., Lea County, New Mexico, for the purpose of including therein Aztec Oil and Gas Company's State No. 3 Well, and other developments.

(3) That the boundaries of the Hare (Simpson) pool, as heretofore established and described, should be changed to include section 15, Township 21 South, Range 37 East.

IT IS THEREFORE ORDERED, That the application of the Oil Conservation Commission of New Mexico, upon its own motion, for the creation of new pools and the extension of existing pools to certain wells in Lea County, New Mexico, is hereby approved, and that the boundaries of the North Brunson (Ellenburger) pool, be, and the same hereby are extended to include:

Township 21 South, Range 37 East, NMPM
Lots 11, 12, 13, 14 in section 2
Lots 9, 10, 15, 16, in section 3

and the boundaries of the Hare (Simpson) pool, be, and the same hereby are extended to include:

Township 21 South, Range 37 East, NMPM
Section 15, all
