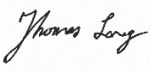
Cause of Release: On October 6, 2021, Enterprise had a release of natural gas and natural gas liquids from the Lateral 10D-5 pipeline. The pipeline was isolated, depressurized, locked and tagged out. An area of approximately 10 feet in diameter was affected by the release fluids. The release was underground. Liquids are also present in the subsurface. No washes/waterway were affected. No residences were affected. No emergency services responded. Remediation and repairs began in the scheduling process. A third party corrective action report will be submitted with the "Final C-141."
