The liquid was determined to be stripped sour which had already passed through a selenium recovery system. A vacuum truck was called out to recover standing liquid. Initially HollyFrontier estimated the amount of liquid recovered at approximately 300bbls; however subsequent information indicates the amount recovered was approximately 390bbls. The exact amount of stripped sour water released could not be determined and is only quantified as greater than 390bbls. All of the water released was contained with earthen secondary containment system. Initial investigation indicates the release came from a compromised welded connection which HollyFrontier believes was caused by freezing temperatures.
