On behalf of Devon Energy Production Company (Devon), New Tech Global Environmental, LLC (NTGE) has prepared this letter to document the liner inspection activities for the Strawberry 7 Federal #002. The site is located at 32.6786232°, -103.9058685° within Unit B, S07, T19S, R31E, and approximately 10.75 miles Southeast of Loco Hills, New Mexico, in Eddy County (Figures 1 and 2).

**Background**

Based on the initial C-141 obtained from the New Mexico Oil Conservation Division (NMOCD), the release was discovered on October 16, 2021, due to equipment failure inside the containment. It resulted in the release of approximately two hundred forty-five (245) barrels of produced water, and two hundred forty-five (245) barrels were recovered. The initial C-141 form is attached in Appendix A.

**Site Characterization**

The site is located within a low karst area. Based on a review of the New Mexico Office of State Engineers and USGS databases, there is no known water source within a ½ mile radius of the location. The nearest identified well is located approximately 1.95 miles South of the site in S19, T19S, R31E. The well has a reported depth to groundwater of 180 feet below ground surface (ft bgs). A copy of the associated *Point of Diversion Summary* report is attached in Appendix B.

### **Regulatory Criteria**

In accordance with the NMOCD regulatory criteria established in 19.15.29.12 NMAC, the following criteria were utilized in assessing the site.

- Benzene: 10 milligrams per kilogram (mg/kg).
- Benzene, toluene, ethylbenzene, and total xylenes (BTEX): 50 mg/kg.
- TPH: 100 mg/kg (GRO + DRO + MRO).
- Chloride: 600 mg/kg.

### **Liner Inspection**

On January 26, 2022, New Tech Global Environmental conducted liner inspection activities to assess the liner's integrity within the facility. NTGE personnel proceeded to inspect the liner visually. The liner was found to be intact with no integrity issues. Refer to the Photolog.

### **Conclusions**

Based on the liner inspection throughout the facility, no further actions are required at the site. The final C-141 is attached, and Devon formally requests closure of the spill. If you have any questions regarding this report or need additional information, please contact us at 432-813-0263.

View Southeast, Area of Lined Containment







View North, Area of Lined Containment


