This pump is manned 24/7 and was immediately shut down. A total of 17 barrels produced water spilled into the booster pump lined containment. A hole was discovered in the containment liner, under the booster pump, which allowed 12 barrels water to leak out of the containment and onto the right-of-way. Hydro vac's are scheduled to start removing impact. An environmental company will assist in remediation.
