Please explain reason for why this event was beyond this operator's control	Tank valve malfunctions resulted in oxygen leaking into tanks. High oxygen in the gas stream caused our third party takeaway to shut us in which resulted in flaring.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Field specialists were called out to repair and make adjustments to the tanks in order to prevent further oxygen leaking into the tanks.
