Please explain reason for why this event was beyond this operator's control	A fuel skid formed a hydrate in a pressure regulator causing a rapid increase of pressure which resulted in an emergency shutdown. This resulted in flaring to occur.
Steps taken to limit the duration and magnitude of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Methanol pumps were activated at the station in order to clear the hydrates to minimize further pressure build up.
