Please explain reason for why this event was beyond this operator's control	A daniel housing on the fuel skid experienced an unexpected malfunction which caused it to leak. This resulted in the venting event.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. Maintenance was contacted to come out and fix the leak.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas vented. Maintenance tightened the housing and stopped it from leaking which ended the venting event.
