Please explain reason for why this event was beyond this operator's control	A valve attached to the oil sight glass providing oil to the compressor experienced a malfunction and was loose which caused the compressor to go down on low oil level. This compressor going down resulted in flaring.
Steps taken to limit the duration and magnitude of vent or flare	All of the facilities and emissions control devices at this site are operating as designed and, where applicable, are authorized. Chevron field personnel will execute practicable measures to minimize emissions. The malfunctioning valve was tightened and the flaring ended.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective measures focused on reducing gas production as quickly and safely as possible to minimize the duration and volume of gas flared. The malfunctioning valve was tightened and repaired.
