**Cause of Release:** On September 10, 2022, Enterprise had a release of natural gas from the Trunk E. The pipeline was isolated, depressurized, locked and tagged out. No liquids were released to the ground surface. No emergency services responded. No fire nor injuries occurred. Remediation and repairs began on September 16, 2022, and Enterprise determined reportable per New Mexico Oil Conservation Division regulation, due to the volume of impacted subsurface soil on September 21, 2022. A third party corrective action report will be submitted with the "Final C-141."

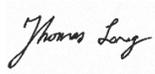
