The downtime increased low pressure flare and shut off tank blowers. Tap Rock saw flare volumes due to flash gas coming off of the tanks and an excess amount of oxygen at the tank level. If flaring continues Tap Rock will alter the facility by placing additional gas takeaway equipment.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Tap Rock saw a higher than normal flare volume due to continuous issues with the VRU unit on location. The downtime increased low pressure flare and shut off tank blowers. Tap Rock saw flare volumes due to flash gas coming off of the tanks and an excess amount of oxygen at the tank level. If flaring continues Tap Rock will alter the facility by placing additional gas takeaway equipment.
