**Comments:** This upset event was not caused by any wells associated with the facility.

## 1. Reason why this event was beyond Operator's control:

This emissions event was caused by the unforeseen, unexpected, sudden, and unavoidable breakdown of equipment or process that was beyond the owner/operator's control and did not stem from activity that could have been foreseen and avoided, and could not have been avoided by good design, operation, and preventative maintenance practices. Oxy engages in respectable and good facility operation practices while also maintaining its continuous facility equipment preventative maintenance program. In this case, this flaring event at the Turkey Track CTB was triggered by sudden and unexpected freezing issues with spillover valve. Valve froze and would not open to relieve pressure to sales line. This caused compression to go down on high pressure. Compressor engines are designed to operate in a precise manner and when any type of malfunction occurs, it disrupts the gas lift compressor's operating manner and cuts off engine power, which in turn, prompts an automatic shutdown of the unit. This facility was unmanned, so as soon as field production technician personnel in the area or associating Oxy facilities received compressor malfunction alarms, they are instructed to head to the facility to determine cause and resolve the issues, if possible. This event is out of OXY's control, yet OXY made every effort to control and minimize emissions as much as possible.

### 2. Steps Taken to limit duration and magnitude of venting or flaring:

It is OXY's policy to route all stranded gas to a flare during an unforeseen and unavoidable emergency or malfunction, as the part of the overall process or steps to take to limit duration and magnitude of flaring. Oxy personnel are in the field 24/7 and can physically see when we are flaring which in turn are communicated to additional Oxy field personnel. Internal OXY procedures ensure that upon gas compressor unit and/or multiple unit shutdown, increased sensor pressure alarms, etc., field production technician personnel are promptly notified, and are instructed to assess the issue as soon as possible to take prompt corrective action and minimize emissions. Oxy field production technician personnel must assess whether the issue or circumstance is due to damage and repair is needed, or whether there are other reasons for its cause. In this case, this flaring event at the Turkey Track CTB was triggered by sudden and unexpected freezing issues with spillover valve. Valve froze and would not open to relieve pressure to sales line. This caused compression to go down on high pressure. Compressor engines are designed to operate in a precise manner and when any type of malfunction occurs, it disrupts the gas lift compressor's operating manner and cuts off engine power, which in turn, prompts an automatic shutdown of the unit. This facility was unmanned, so as soon as field production technician personnel in the area or associating Oxy facilities received compressor malfunction alarms, they are instructed to head to

the facility to determine cause and resolve the issues, if possible. Production Technician arrived at location and began troubleshooting and found that valve was not opening. He then tried to reduce flaring by sending gas to another third party. They were unable to receive gas at the time. Production technician then began to shut in wells until valve was able to be in thawed and compression could be restarted. This event is out of OXY's control, yet OXY made every effort to control and minimize emissions as much as possible.

### 3. Corrective Actions taken to eliminate the cause and reoccurrence of venting or flaring:

Oxy is limited in its ability to take any corrective actions to eliminate the cause and potential reoccurrence of Valve malfunctions. However Oxy has added heat trace and added more insulation to keep valve from freezing up. Oxy continually strives to maintain and operate its facility equipment in a manner consistent with good practices for minimizing emissions and reducing the number of emission events. Oxy has a strong and positive equipment preventative maintenance program in place. The only actions that Oxy can take and handle that is within its control, is to keep continue with its equipment preventative maintenance program for this facility.
