Hey Tyra,

A line leak was discovered at the Ohwada #2 this morning during an LDAR inspection. Checking the meter, a pressure drop was detected around midnight on 4/8/23.

Based on this information it is estimated the line was venting for 42 hours.

The hole was too small to measure. The pressure differential was roughly 11.5 psi.

Based on the information collected by field crews. My calculated estimated volume vented is 6 MCF.
