After replacing piping from tanks to the suction side on water transfer pump, a 2" 150 gasket was re-installed in a 3" 150 flange. This allowed a total of 30 barrels produced water to be released into containment and on to the facility pad. All fluids remained on the pad. A vac truck recovered a total of 28.5 barrels from containment and the pad. The containment will be washed and impacted material will be scheduled for remediation in the coming weeks. Spilled: 30 barrels water (28 barrels inside containment + 2 barrels on well pad) Recovered: 28.5 barrels (28 barrels inside containment + 0.5 barrels from well pad)
