Upon arriving on location for a routine check, the operator discovered produced water running from underneath the aboveground pit tank. After further inspection, it was determined that an equipment failure occurred at the pit tank due to a 2-inch pinhole leak at the bottom of the pit tank, most likely due to corrosion. Although the spilled fluids did not migrate horizontally outside of secondary containment, none of the fluids could be recovered since the secondary containment area is unlined. Area 2 operations will work with Integrity to assess the tank and re-coat.
