Informed Robert Griffin to:

- 1) Submit the State of New Mexico OCD Form C-141
- 2) Obtain a 3rd party environmental company since the rancher/lease owner Kenneth Augustine had called about the release
- 3) Fully delineate the area affected by the release
- 4) Release will require removal of soil with volumes dictated by concentrations of chlorides, BTEX, TPH, etc. found during delineation.

Robert Griffin stated he will contact the environmental contractor in Midland that he uses to delineate the spill. He will also submit the correct C-141 form.


