Shortly after beginning to pump, the truck caught fire. Likely caused from a hole in the coils. The fire department used water to cool the tanks and put out the fire resulting in the spreading of the oil draining from the hole in coils. Once the fire was out, we were able to use a vac truck to empty the remaining 21 bbls of oil from the burned vac truck and transport back to the oil tank.
