Release Volume: 41bbls of produced water released due to equipment failure. Hydraulic hose was resting against a 1/2" bleeder valve on top of filter pot causing valve to open from vibration. Water overflowed sump and ran outside building onto location and outside the perimeter fence approximately 150' off location.

Release volume estimate is based on the dimensions of the impacted area on the ground.
