Steps taken to limit the duration and magnitude of vent or flare	Pipeline was shut-in and blowdown as efficient and effective as possible to limit the duration and magnitude of the vent and to ensure public and worker safety. Pipeline blowdown was flared to reduce emission. Flaring causes the blowdown duration to lengthen.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Pipeline was repaired before putting back into service.
