Steps and Actions to Prevent Waste	
For this event, this operator could not have reasonably anticipated the current event and it was beyond this operator's control.	True
Please explain reason for why this event was beyond this operator's control	The event was beyond the operator's control because it was caused by an unplanned failure of the contact tower, which triggered an automatic shutdown of the compressor station. Once the failure occurred, the system routed gas to the flare as a safety response to manage pressure. Operators did not initiate or have the ability to prevent the equipment failure, and their actions were limited to stabilizing and restarting the facility.
Steps taken to limit the duration and magnitude of vent or flare	Operators responded by safely shutting down the compressor station and routing gas to the flare to manage system pressure. The contact tower was bled down and the facility was systematically brought back online, minimizing the duration and volume of flaring. Intermittent operations were used to stabilize the system as quickly and safely as possible.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	Corrective actions focused on diagnosing and addressing the contact tower failure, safely restoring the compressor station to normal operation, and verifying system functionality to prevent recurrence.
