The release was the unintentional result of an increase in borehole pressure, due to an apparent interception of a fracture into the North El Mar 059 well. The 059 was shut in at the time of the release and hydraulic fracture stimulation of EOG wells was occurring at the time, approximately 800 ft due south, just across the state line. As an emergency measure, Sahara excavated an earthen sump to minimize the spread of the produced water over the surface. This containment was monitored daily and fluid removed as needed during the flow of produced water from the inactive well. On March 9, 2026, a bridge plug was set at 4381 feet and the release stopped. Discussions between BLM and Sahara resulted in Sahara believing that the release was a downhole maintenance/operations issue only and worked to stop the flow. Subsequent discussion with BLM clarified that this issue was a release that requires notification and report to OCD. NM811 has cleared and assessment samples will be initiated promptly with 48 hours' notice to OCD. The reported volume will be based on experienced field/visual estimates and disposal records, but we can currently state the total volume may be approximately 88 barrels although significant and consistent recovery occurred and will be subsequently reported. The 059 remains shut in and is scheduled for P&A.
