- **Cause and Nature of flaring:** On August 7, 2026, the EVLRP Plant experienced flaring as a result of a plant-wide compressor shutdown caused by a power outage. The outage originated from the local utility provider, Lea County Electric Cooperative (LCEC), resulting in the loss of all plant compressors and necessitating flaring during the event.
- **Steps taken to limit duration and magnitude of venting:** EPN Flare is only used during upsets and emergencies. The flare is operated with best management practices during flaring events. This event was beyond operations control.
- **Corrective actions taken to eliminate the cause and recurrence of:** Operations personnel immediately curtailed production by shutting in RWA wells and pinching the South Inlet Valve to reduce inlet gas volumes to the facility. Once electrical service was restored and field production began returning online, all plant compressors were systematically restarted and returned to service to reestablish normal operating conditions and minimize further flaring.
