Steps taken to limit the duration and magnitude of vent or flare	Operations personnel responded immediately to the unexpected shutdown and contacted I&E personnel to troubleshoot.
Corrective actions taken to eliminate the cause and reoccurrence of vent or flare	I&E personnel uploaded the program to the failed PLC. Units were restarted, normal operations resumed and flaring ceased.
