To Whom It May Concern:

Earth Systems Response and Restoration (ESRR), presents the following Closure Request Report (CRR) to document the findings during a recent liner inspection conducted at Right Meow 30 CTB 1 (Site) following an inadvertent release of produced water within a lined secondary containment (LSC). Based on initial release response and liner inspection activities, Devon Energy (Devon) is requesting No Further Action (NFA) at the Site.

Site Location

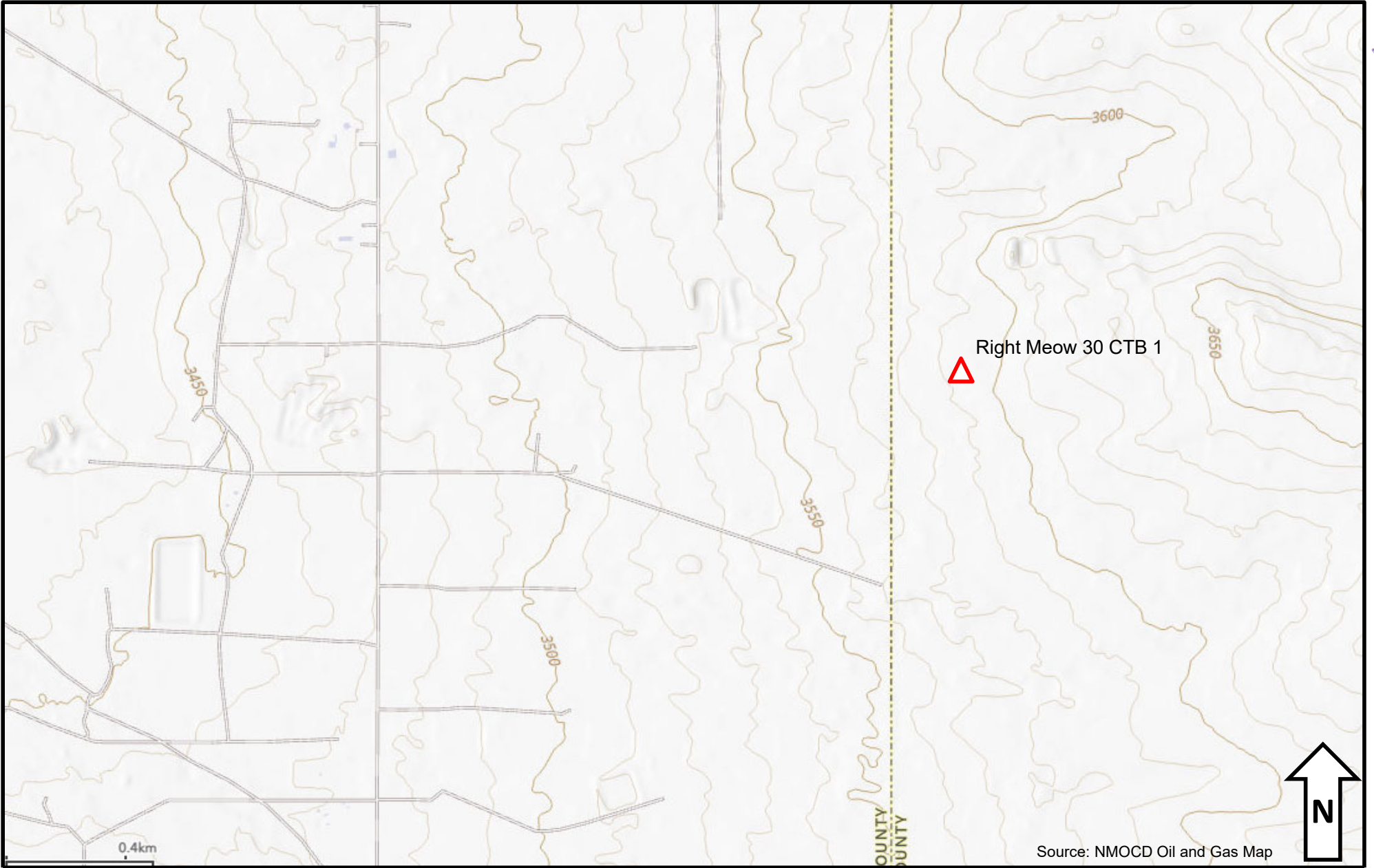


Figure 1 – Site Map

The Site is located in Unit L, Section 30, Township 23 South, Range 32 East, in Lea County, New Mexico (32.2797774°, -103.7206055°) and is associated with oil and gas exploration and production operations on Federal Land managed by the Bureau of Land Management (BLM) (**Figure 1**).

Incident Description & Background

On May 9, 2026, a ball valve failed, releasing approximately 7 barrels (bbls) of produced water within a LSC (**Figure 2**). The release was fully contained within the LSC with no fluids escaping to the production pad or adjacent native soils. A vacuum truck was immediately dispatched to the Site recovering the 7 bbls of produced water.

Notice was given to the New Mexico Oil Conservation Division (NMOCD) on May 11, 2026, by Notification of Release (NOR) and subsequently assigned Incident Number nAPP2613126020. A Corrective Action Form C-141 (Form C-141) was later submitted and approved by the NMOCD on May 19, 2026.

On June 9, 2026, Devon submitted a 48-hour Notification of Liner Inspection (Form C-141 L) for June 11, 2026.

On August 6, 2026, Devon requested an extension of the August 7, 2026 deadline, to allow additional time to complete this CRR. It should be noted that ESRR inadvertently stated in the extension request that remediation and restoration activities had been completed; however, ESRR intended to indicate that the liner inspection had been completed. Devon was subsequently granted a 90-day extension by the NMOCD, extending the deadline to June 6, 2026.

Site Characterization

ESRR characterized the Site according to Table I, Closure Criteria for Soils Impacted by a Release, of Title 19, Chapter 15, Part 29, Section 12 (19.15.29.12) of the New Mexico Administrative Code (NMAC). The following proximities were estimated:

- Between 1 and 5 miles of any continuously flowing watercourse or any other significant watercourse;
- Between 1 and 5 miles of any lakebed, sinkhole or playa lake (measured from the ordinary high-water mark);
- Between 1 and 5 miles of any occupied permanent residence, school, hospital, institution or church;
- Between 1 and 5 miles of any spring or a private, domestic fresh water well used by less than five households for domestic or stock watering purposes;
- Between 1 and 5 miles of any other freshwater well or spring;
- Greater than 5 miles of any incorporated municipal boundary or a defined municipal fresh water well field covered under a municipal ordinance;
- Between 1 and 5 miles of any wetland;
- Greater than 5 miles of any subsurface mine;
- Between 1 and 5 miles of a unstable area (non-karst); and
- Greater than 5 miles of a 100-year floodplain.

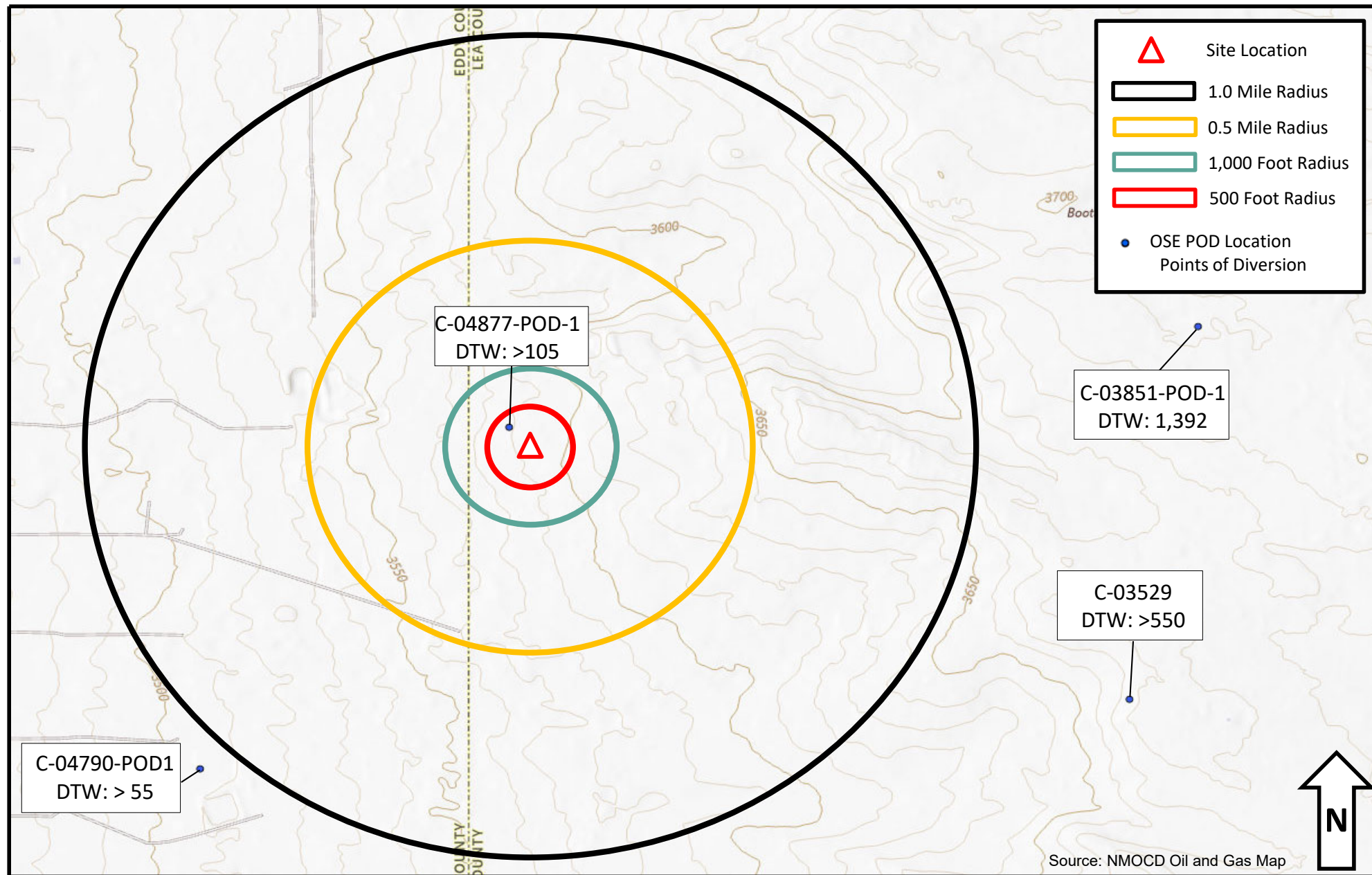


Figure 3 – Groundwater

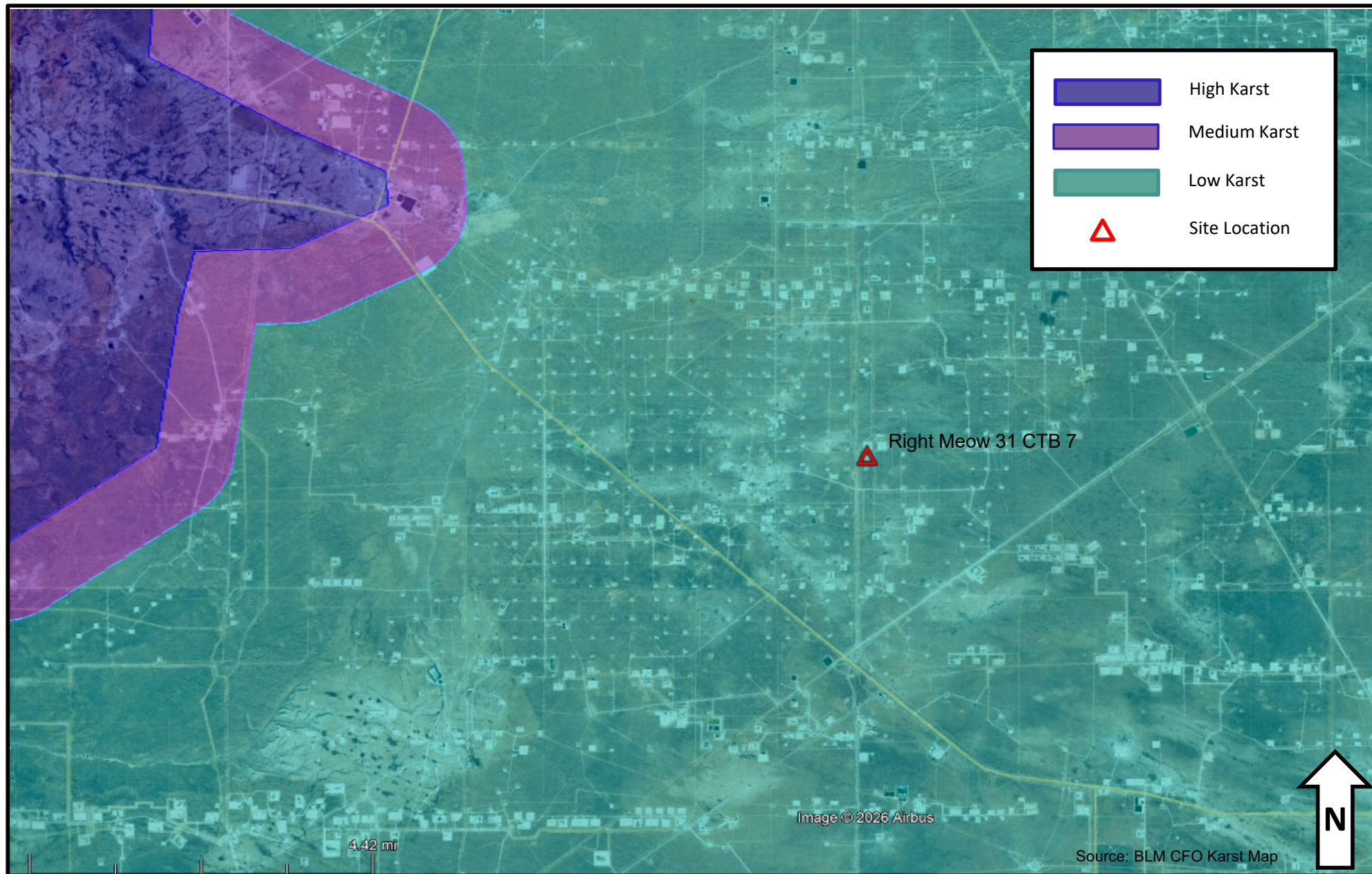


Figure 4 – Karst Potential

Receptor details used to determine the Site characterization are included in **Figure 3** and **Figure 4**. **Referenced Well Records** for the closest depth to groundwater (DTW) well are attached.

Based on the results from the desktop review, the Site is designated with medium karst potential with no DTW well within ½ mile with data no greater than 25 years old. The following Closure Criteria was applied:

Liner Inspection

On June 11, 2026, ESRR conducted a thorough visual inspection of the LSC and found no tears, cracks, cuts, breaks, or other signs of damage, confirming no evidence of a breach to the LSC. The liner appeared to be in good condition and is performing as designed. **Photographic Documentation** of liner inspection activities is attached.

Closure Request

Based on initial release response and liner inspection activities, Devon believes the completed remedial actions meet the requirements set forth in NMAC 19.15.29.13 regulations in order to be protective of human health, the environment, and groundwater. Devon believes NFA is warranted at the Site and respectfully requests Closure for Incident Number nAPP2613126020. If you have any questions or

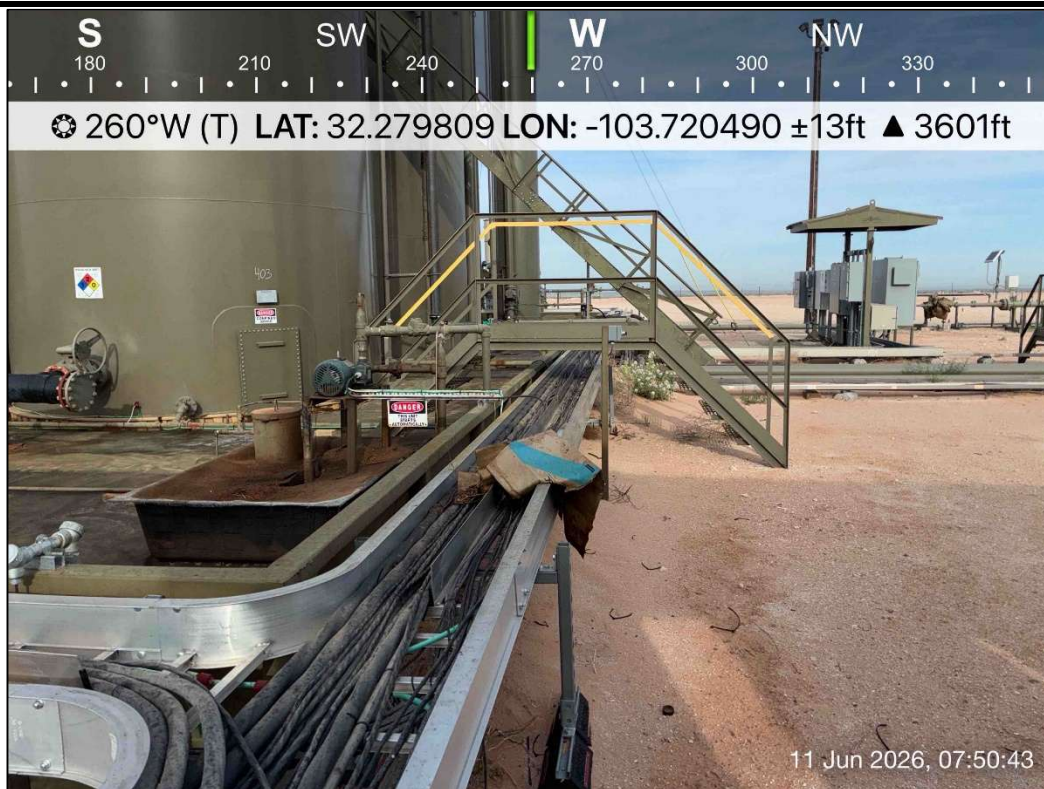


PHOTO 4: Western view outside of containment during liner inspection activities. 6/11/2026

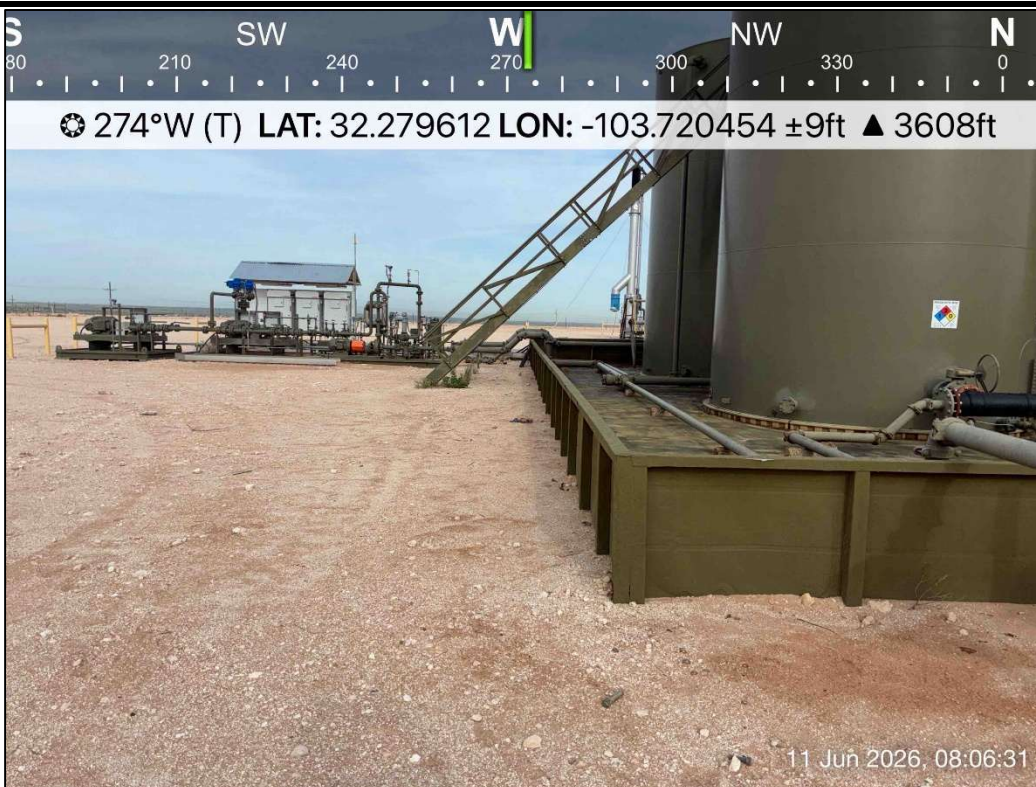


PHOTO 6: Western view outside of containment during liner inspection activities. 6/11/2026

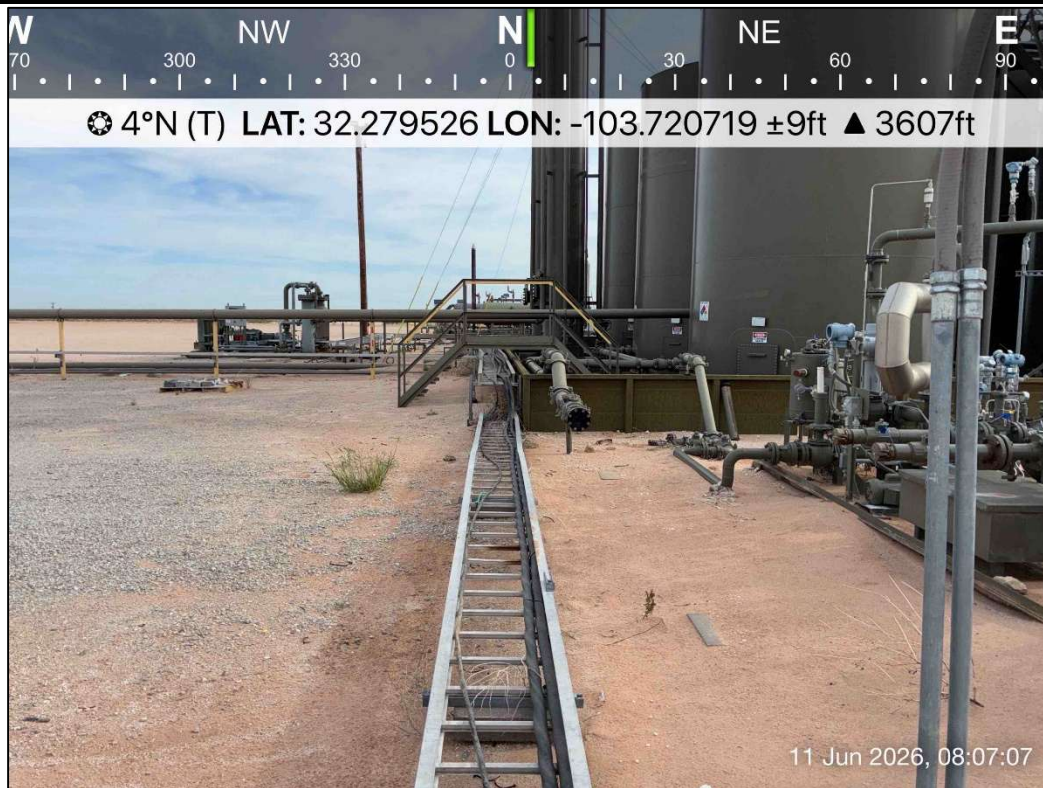


PHOTO 7: Northern view outside of containment during liner inspection activities. 6/11/2026

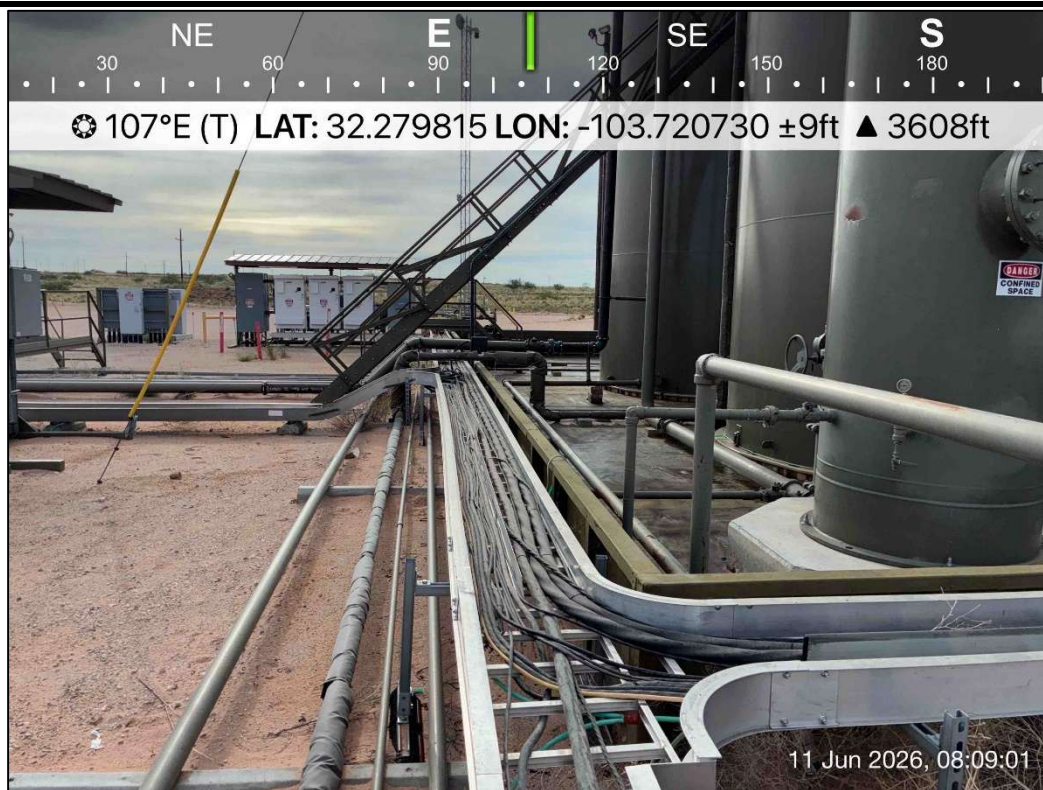


PHOTO 8: Eastern view outside of containment during liner inspection activities. 6/11/2026

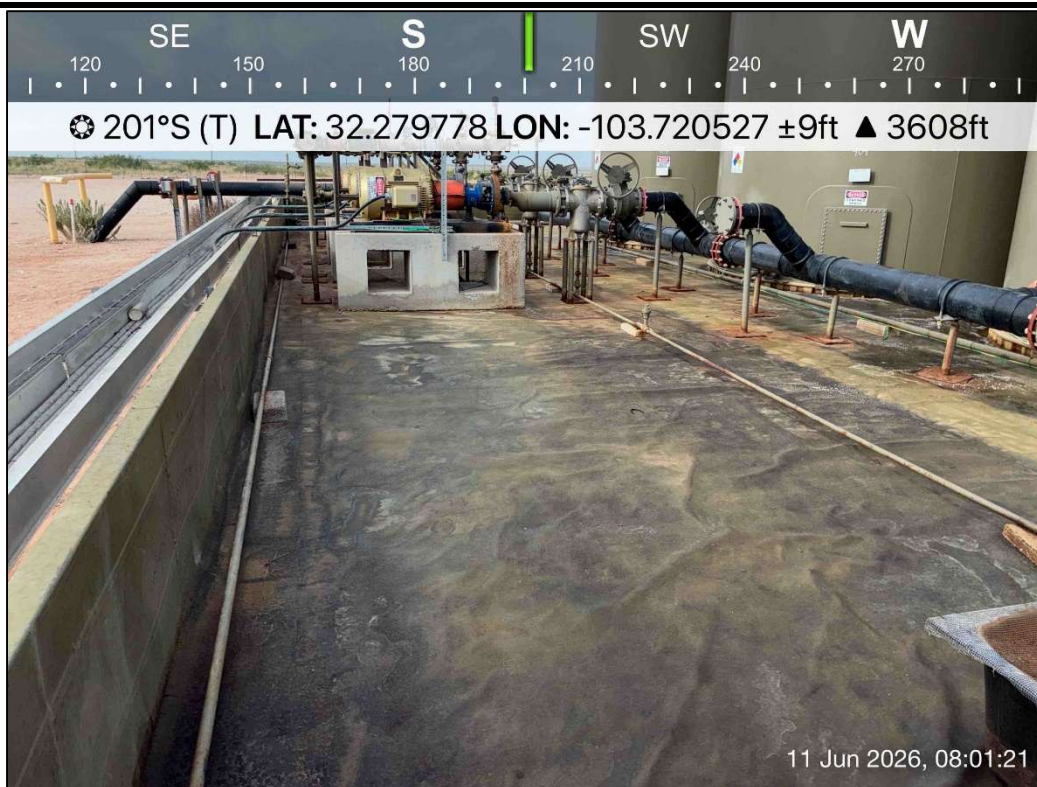


PHOTO 9: Southern view during liner inspection activities. 6/11/2026

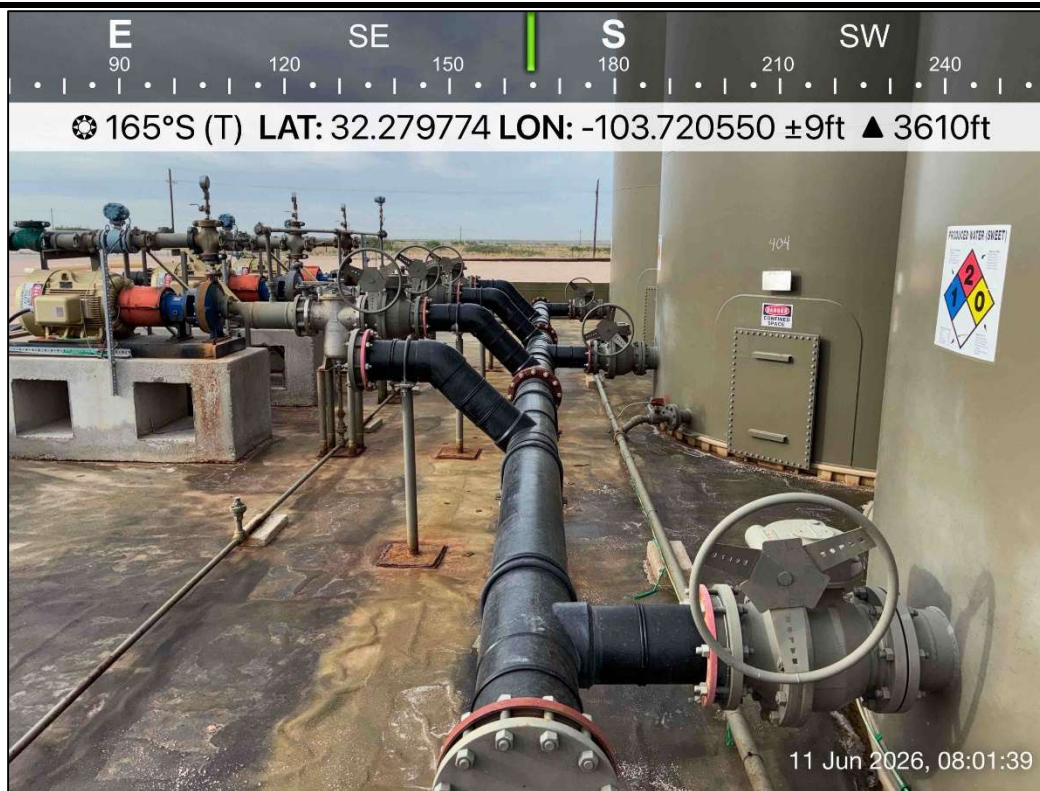


PHOTO 11: Southeastern view during liner inspection activities. 6/11/2026

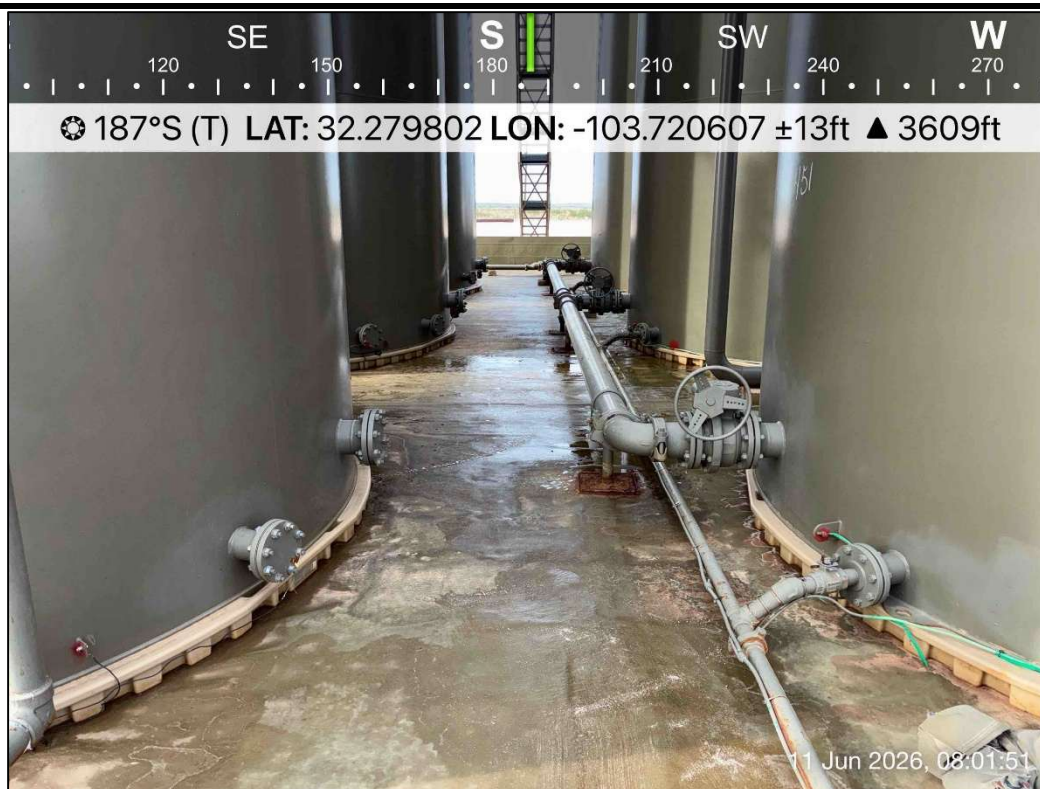


PHOTO 12: Southern view during liner inspection activities. 6/11/2026

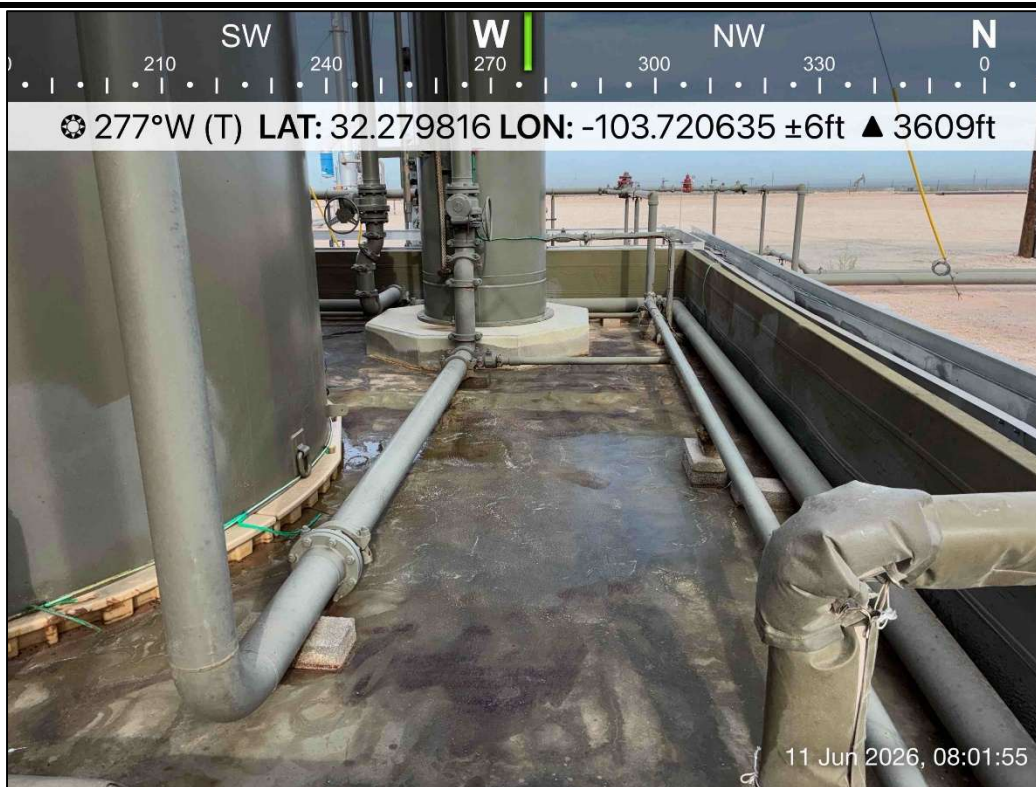


PHOTO 13: Western view during liner inspection activities. 6/11/2026

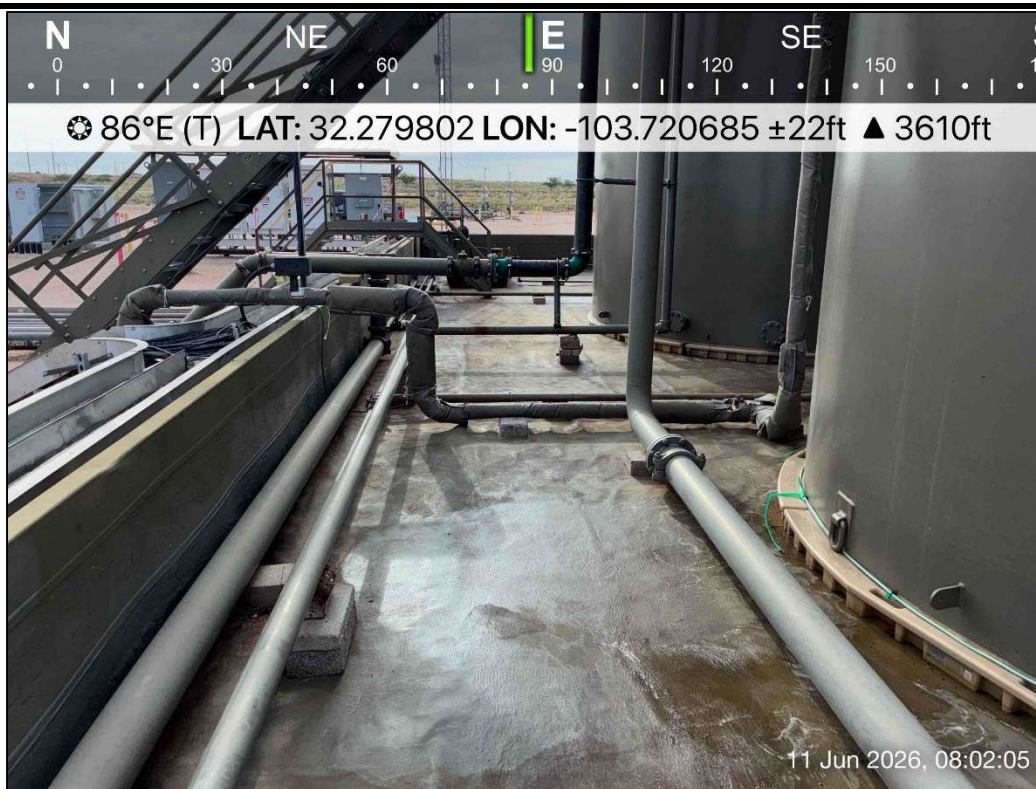


PHOTO 14: Eastern view during liner inspection activities. 6/11/2026

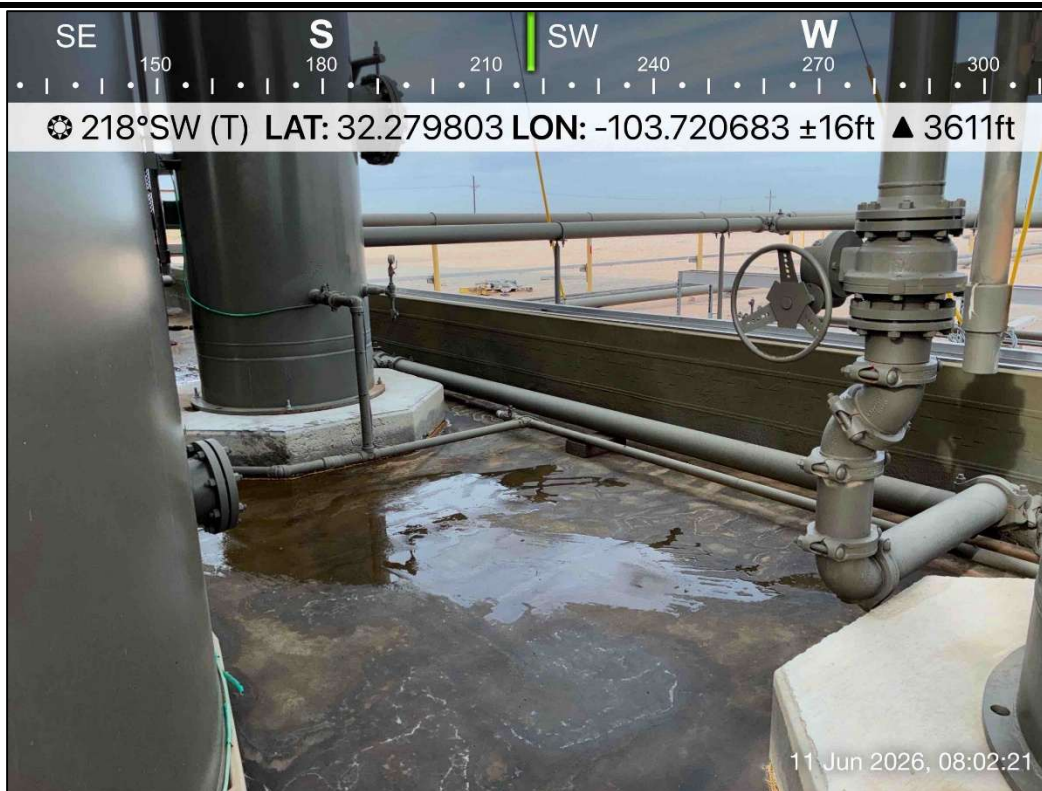


PHOTO 15: Southeastern view during liner inspection activities. 7/11/2025

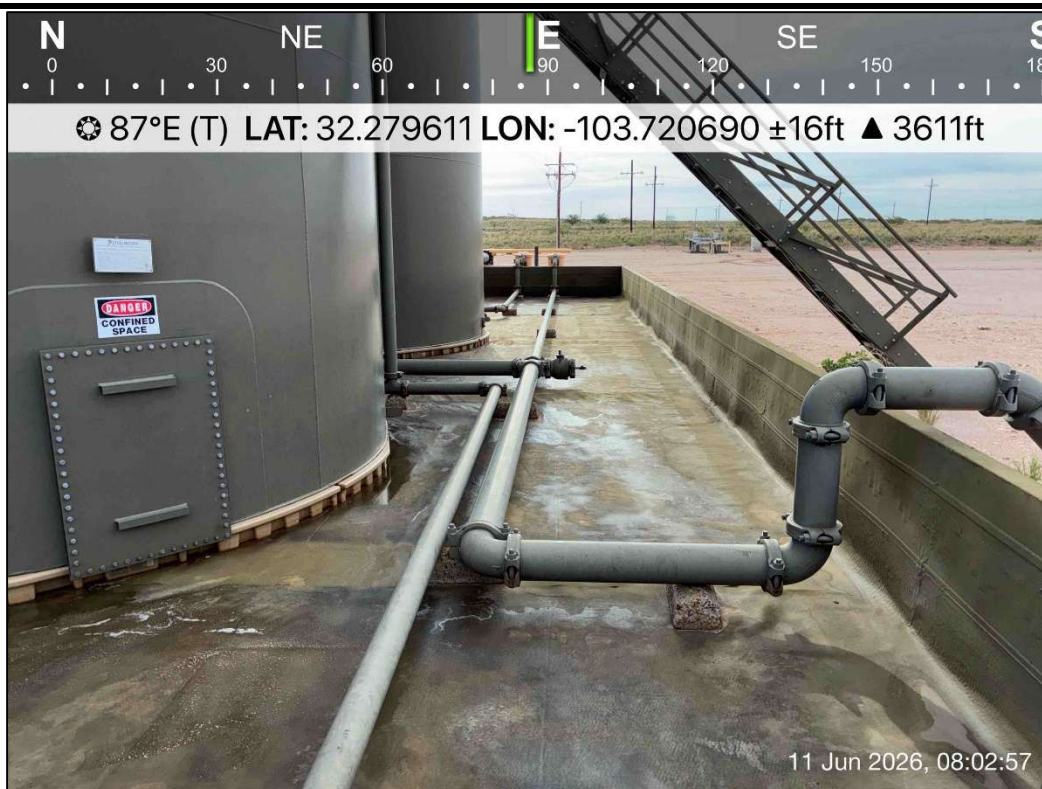


PHOTO 16: Eastern view during liner inspection activities. 6/11/2026

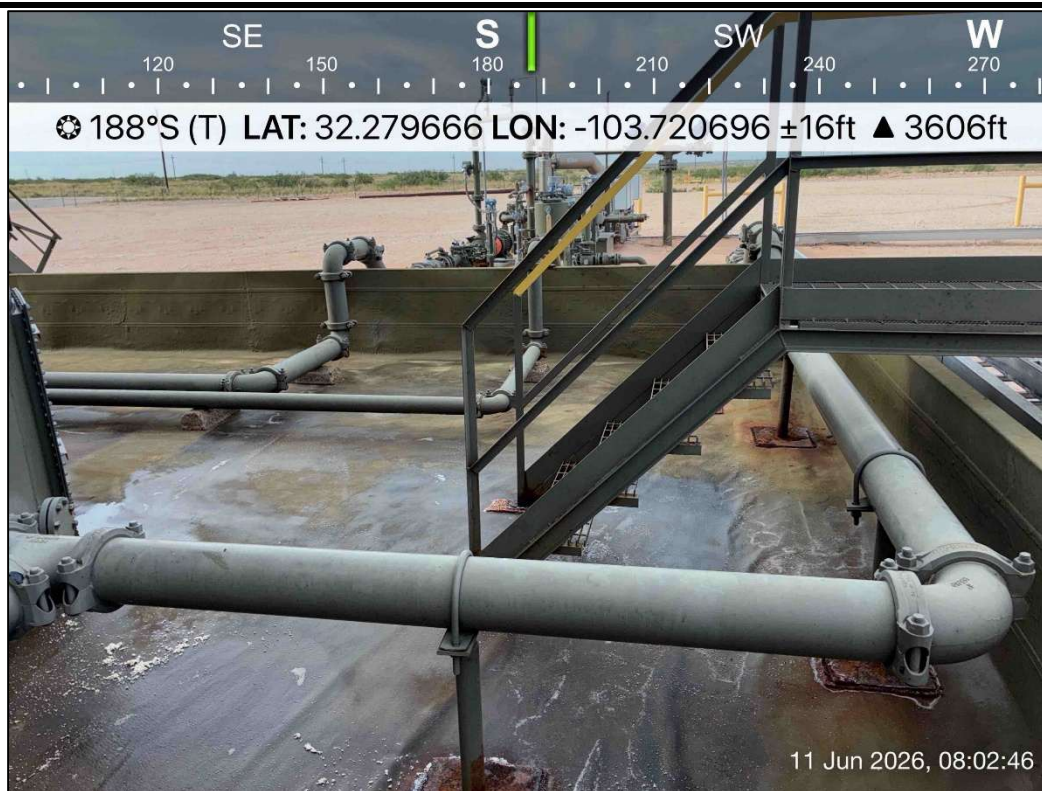


PHOTO 17: Southern view during liner inspection activities. 6/11/2026

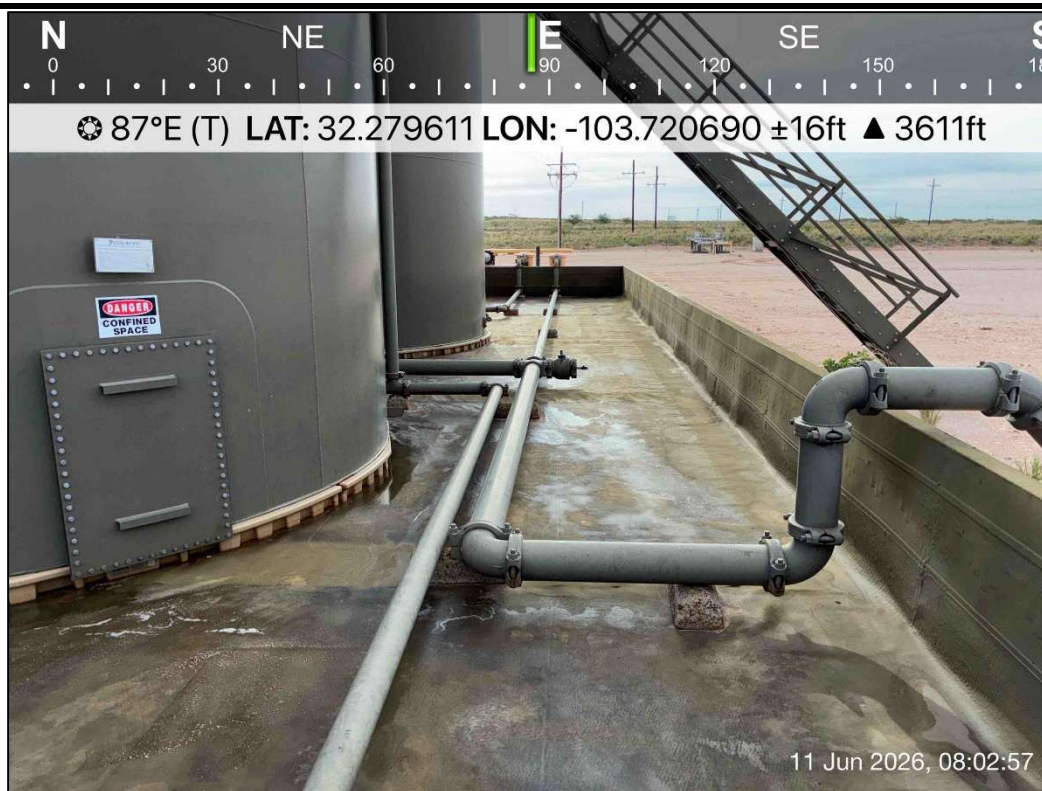


PHOTO 18: Eastern view during liner inspection activities. 6/11/2026

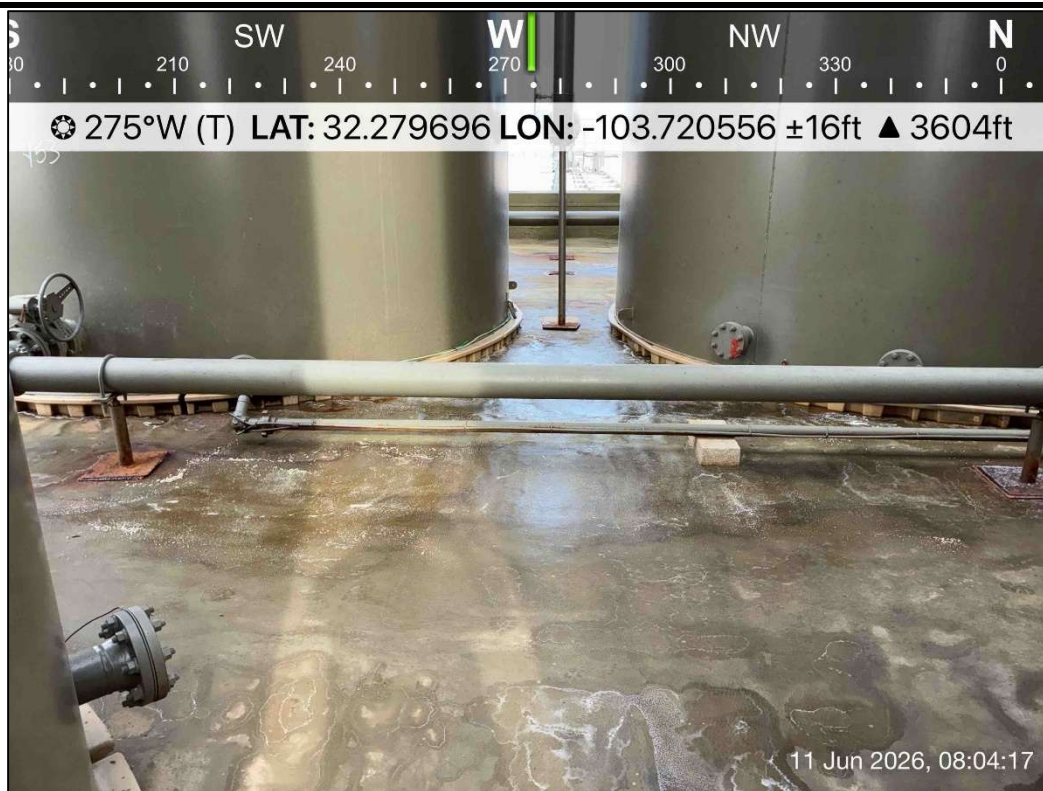


PHOTO 19: Western view during liner inspection activities. 6/11/2026

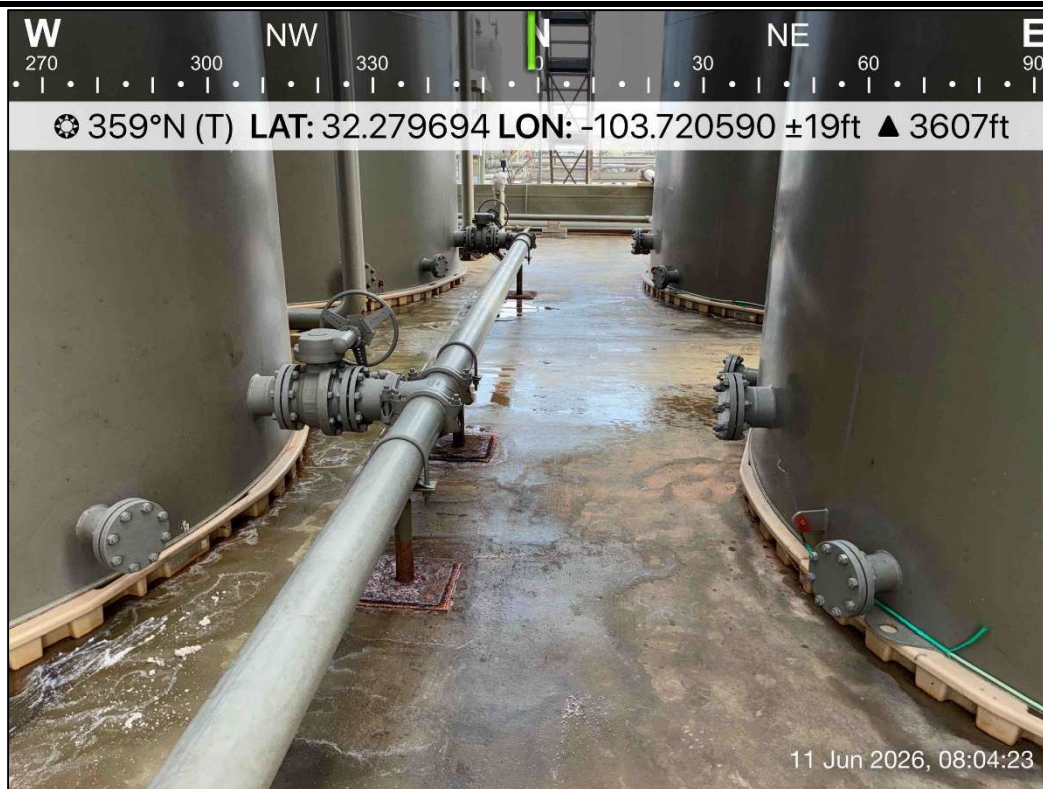


PHOTO 20: Northern view during liner inspection activities. 6/11/2026

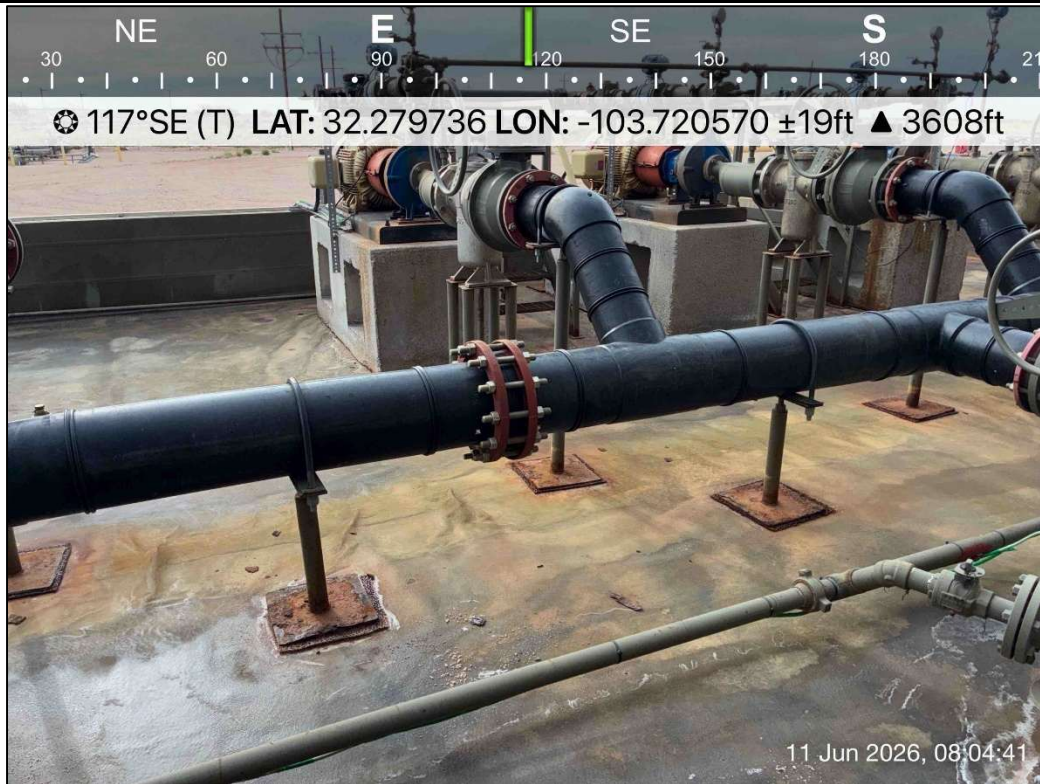


PHOTO 21: Southeastern view during liner inspection activities. 6/11/2026
