A Facility Engineer found the Vapor Recovery Unit (VRU) was on fire immediately ESD. The fire was extinguished using a fire extinguisher. The cause of the fire is currently under investigation. As a result of the incident, approximately 7 gallons of motor oil were released into the lined containment. The fire remained contained to the VRU, and no emergency response assistance was required. • The fire was extinguished with a fire extinguisher. • No Fire Department was notified nor responded to the incident. • No injuries were reported because of the fire. • The incident occurred in an area with no public visibility. • Impacts were confined to the VRU, with no known impacts to surrounding infrastructure or resources. • The facility is in a low-karst area, and no impacts have been identified to wetlands, significant watercourses, or other sensitive environmental resources. An assessment of the affected area will be scheduled in the coming weeks, and a liner inspection will be completed to verify containment integrity.
