02/04/05 Spud @ 4:00 a.m.. Drill 11" surface hole to 341'. Run 8 jts. of 8 5/8", 24#, J55 ST&C casing to 331'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate 6 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.

02/05/05 Drill 7 7/8" hole from 341' - 2,635'. Reached TD 2,635' at 7:30 p.m. MIRU Patterson and log well. Logger's TD at 2,612'. Ran 62 jts of 5 1/2", 15.5#, J55 LT&C casing to 2,569'. MIRU Halliburton. Pumped water and gel spacer at 4 bpm, with 80 psi. Pumped 362 sks Midcon II at 13 ppg, 2.04 yield. Bumped plug with 1,470 psi. Circulated 1 bbls of cement to surface. Well shut in.
