02/15/05 Spud @ 3:30 p.m.. Drill 11" surface hole to 347'. Run 8 jts. of 8 5/8", 24#, J55 ST&C casing to 337'. Halliburton mixed and pumped 100 sx Midcon II, 14 ppg, yield 1.66. Circulate 14 bbls of cement to surface. WOC 8 hrs. Test surface 8 5/8" csg to 500 psi for 30 minutes.
02/16/05 Drill 7 7/8" hole from 347' - 1,495'. Reached TD 1,495' at 9:00 a.m. MIRU Patterson and log well. Logger's TD at 1,475'. Ran 34 jts of 5 1/2", 15.5#, J55 LT&C casing to 1,422'. MIRU Halliburton. Pumped water and gel spacer at 4 bpm, with 80 psi. Pumped 199 sks Midcon II at 13 ppg, 2.04 yield. Bumped plug with 1,065 psi. Circulated 11 bbls of cement to surface. Well shut in.
